ORDINANCE NO. 20-

AN ORDINANCE OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, EXTENDING THE MORATORIUM ADOPTED BY ORDINANCE 19-13; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Cutler Bay (the "Town") is committed to providing a sustainable community for its residents and future generations; and

WHEREAS, on July 17, 2019, the Town Council adopted Ordinance No. 19-13, which provided for a moratorium on development within the Town; and

WHEREAS, Town staff is seeking a three-month extension to the moratorium in order to compile, review, host a community workshop and finalize the analyses and regulations for:

- a. Mobility
- b. Sustainability and Resiliency
- c. Architecture and Landscape; and,

WHEREAS, the Town Council, in its capacity as the Local Planning Agency, has reviewed this Ordinance and has recommended approval; and

WHEREAS, after due notice and hearing, the Town Council finds that this Ordinance is consistent with the Town's Comprehensive Plan and Code of Ordinances; and

WHEREAS, the Town Council finds that this Ordinance is necessary for the preservation and improvement of the environment, public health, safety and welfare of the Town.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA AS FOLLOWS:1

Section 1. Recitals. The above-stated recitals are true and correct and are incorporated herein by this reference as the legislative intent of this Ordinance.

Moratorium Extension. Pursuant to Section 8 of Ordinance No. Section 2. 19-13, the Town Council hereby extends the moratorium on development for an additional three (3) months to April 17, 2020. Section 3. Severability. If any section, clause, sentence, or phrase of this Ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, the holding shall not affect the validity of the remaining portions of this Ordinance. Section 4. Conflicts. All Sections or parts of Sections of the Code of Ordinances, all Ordinances or parts of Ordinances, and all Resolutions, or parts of Resolutions, in conflict with this Ordinance are repealed to the extent of such conflict. Section 5. **Effective Date.** This Ordinance shall be effective immediately upon adoption on second reading. PASSED on first reading on the 20th day of November, 2019.
