Pursuant to Executive Order 20-69, "any Florida Statute that requires a quorum to be present in person or requires a local government body to meet at a specific public place" is suspended, and the Town is authorized to hold public meetings through the use of communications media technology, subject to the adoption of rules pursuant to Section 120.54(5)(b)2, Florida Statutes. On June 24, 2020, Governor DeSantis issued Executive Order 20-150, which extended Executive Order 20-69 until 12:01 a.m. on August 1, 2020. On April 14, 2020, Town Manager Casals issued Emergency Order No. 20-03, providing rules of procedure for Public Meetings utilizing communications media technology, including instructions on how to access the public meeting either via telephone, video conference, or other communications media technology utilized by the Town. On June 25, 2020, Town Manager Casals issued Emergency Order 20-06, providing rules of procedure for Virtual Quasi-Judicial Hearing Public Meetings through the use of communications media technology.

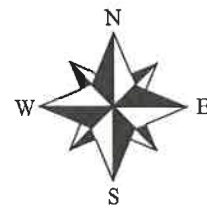

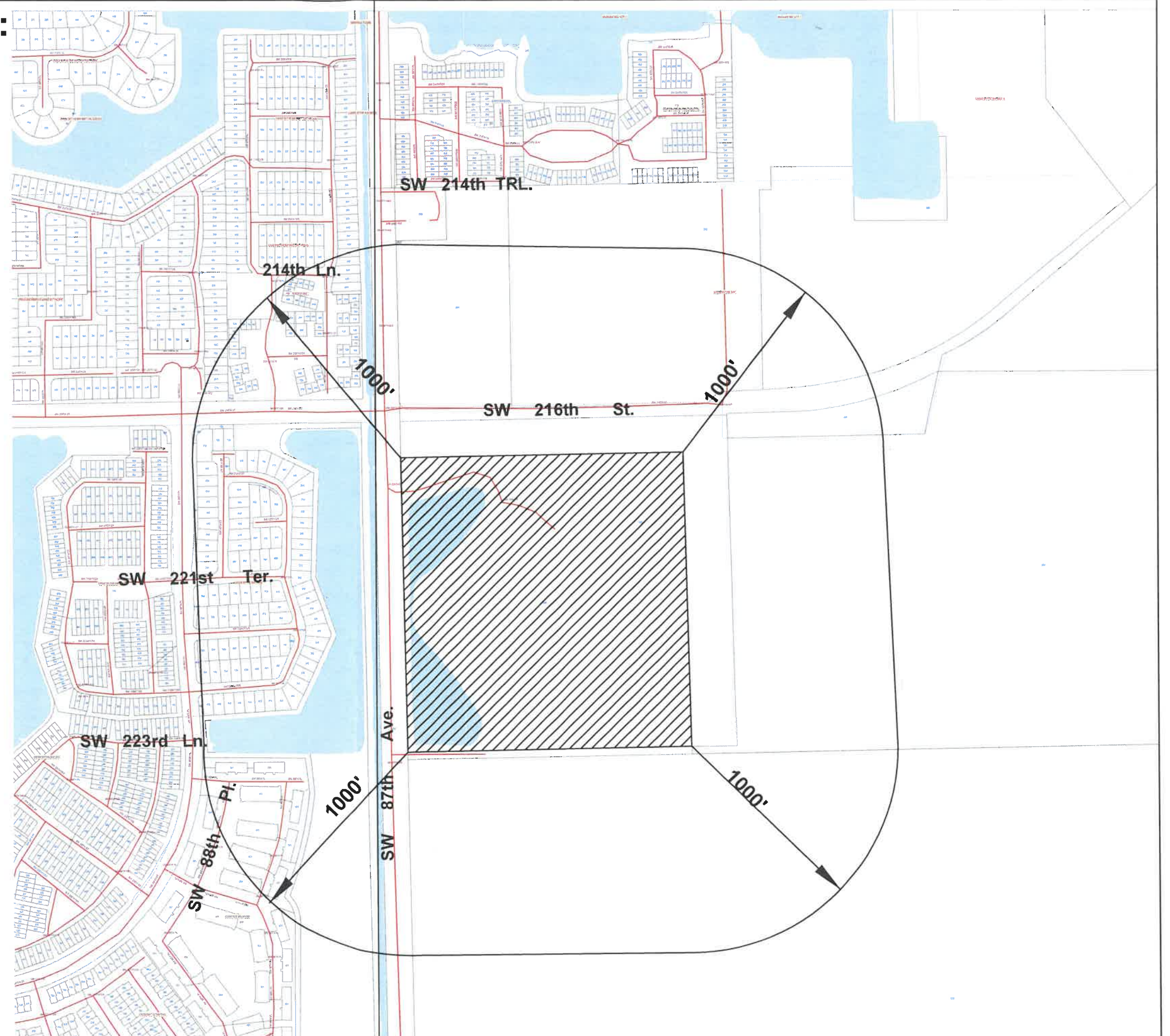
