

RESOLUTION 13-86

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, URGING THE MIAMI-DADE COUNTY SCHOOL BOARD TO SUPPORT THE REQUEST OF THE CUTLER BAY YOUTH COUNCIL COMMITTEE AND TOWN COUNCIL BY RENAMING CUTLER BAY SCHOOLS AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on October 17, 2012, the Town of Cutler Bay (the "Town") Town Council created the Youth Council Committee (the "Committee") to promote community service and foster a better understanding among young people; and

WHEREAS, the Youth Council Committee members have been appointed and have met to discuss issues of concern to the community and community youth; and

WHEREAS, the Youth Council Committee through its Chair periodically provides advisories to the Mayor and Town Council of the Town of Cutler Bay; and

WHEREAS, at the October 16, 2013 Town Council Meeting, the Youth Council Committee requested that the Town Council strongly urge the Miami-Dade County School Board to change the name of Cutler Bay Academy for Advanced Studies – Centennial Campus to Cutler Bay Academy Senior High, and to change the name of Cutler Bay Academy of Advanced Studies – Cutler Ridge Campus to Cutler Bay Academy Middle School; and

WHEREAS, the Town Council finds that this Resolution will promote the health, safety and welfare of the residents of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Recommendation. The Mayor and Town Council of the Town of Cutler Bay strongly urge that the Miami-Dade County School Board change the name of Cutler Bay Academy for Advanced Studies – Centennial Campus to Cutler Bay Academy Senior High and also change the name of Cutler Bay Academy of Advanced Studies – Cutler Ridge Campus to Cutler Bay Academy Middle School.


Section 3. Effective Date. This resolution shall take effect immediately upon adoption.
