

RESOLUTION 19-_____

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL
OF THE TOWN OF CUTLER BAY, FLORIDA, ADOPTING
AND IMPLEMENTING THE TOWN OF CUTLER BAY
WATERSHED MASTER PLAN; AND PROVIDING FOR AN
EFFECTIVE DATE.**

WHEREAS, the Town of Cutler Bay (“Town”) Public Works Department (“Department”) is responsible for overseeing the implementation of the Town’s Floodplain Management Program; and

WHEREAS, the Town is an active participant in the Federal Emergency Management Agency’s (“FEMA”) National Flood Insurance Program’s (“NFIP”) Community Rating System (“CRS”), which encourages communities to voluntarily implement standards, policies, and programs that go beyond the minimum NFIP regulations which result in lower flood insurance premiums for the area located within the community; and

WHEREAS, in May 2011, the Town first entered into the CRS with a classification rating of a six (6), which provides for annual flood insurance savings of twenty percent (20%); and

WHEREAS, on May 20, 2015, pursuant to Resolution 15-27, the Town Council adopted the Revised Floodplain Mitigation Plan, which lowered the Town’s overall CRS classification rating from a six (6) to a five (5) and resulted in an annual flood insurance savings of twenty-five percent (25%) within the Town; and

WHEREAS, the Town’s recent CRS Verification Report resulted in over three thousand (3,000) points, making the Town eligible for a CRS classification rating of four (4) and an annual flood insurance savings of thirty percent (30%), if the Town meets a prerequisite of developing and adopting a Watershed Master Plan; and

WHEREAS, on September 27, 2017, the Town Council adopted Resolution No. 17-75, authorizing Amec Foster Wheeler Environment & Infrastructure, Inc. (now known as Wood Environmental & Infrastructure Solutions, Inc.) (“Consultant”) to develop a Watershed Master Plan (“Master Plan”); and

WHEREAS, the Consultant developed the Master Plan, attached hereto as Exhibit “A”; and

WHEREAS, the Town Council finds that adoption of the Master Plan is in the best interest of the health, safety and welfare of the residents of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Adoption and Implementation of the Master Plan. That the Town Council hereby adopts the Master Plan, in substantially the form attached hereto as Exhibit "A." The Town Manager is authorized to take all actions necessary to implement the stormwater standards identified in the Master Plan.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.
