1. CALL TO ORDER, ROLL CALL, PLEDGE OF ALLEGIANCE, MOMENT OF SILENCE & INVOCATION

Mayor Bell called the meeting to order at 7:18PM. Town Clerk Jacqueline Wilson called the roll. Mayor Bell led the Pledge of Allegiance. Mayor Bell led a Moment of Silence in honor and memory of the victims and families in the Orlando, Florida tragedy.

2. PROCLAMATIONS, AWARDS, AND PRESENTATIONS

A. Proclamation- Cutler Bay Senior High School Inaugural Class 2016

Mayor Bell acknowledged Cutler Bay Senior High School Principal Lucas De La Torre, Cutler Bay Ocean Academy of Science and Technology (COAST) Lead Teacher Marshall Ruffo, Former Principal Yamila Carballo, Lead Teacher Dr. Justin Koren, Student Council President Autumn LeBron, and Student Council Treasurer Livan Bec, Jr. in attendance. Mayor Bell and members of the Town Council presented a proclamation honoring the Cutler Bay Senior High School Inaugural Class of 2016.

Town Attorney Mitchell Bierman informed the Council and the public that the applicants for Quasi-Judicial items 9A through 9H requested deferral to date certain July 20, 2016. Town Attorney Mitchell Bierman also informed that the applicants for Quasi-Judicial item 9I and Ordinance for First Reading item 11B have requested withdrawal of their applications, and announced the addition of Resolution item 8A to the agenda.

A motion was made by Vice Mayor Sochin, seconded by Council Member Loyzelle to defer Quasi-Judicial items 9A through 9H to date certain July 20, 2016. Council Member Coriat expressed concern for recurring deferrals. Town Attorney Mitchell Bierman provided background information on the requests for deferral. Council Member Mixon expressed concern for recurring deferrals. After discussion, an amended motion was made by Council Member Coriat, seconded by Council Member Mixon to vote separately for deferral on Quasi-Judicial items 9A through 9G and Quasi-Judicial item 9H. Mayor Bell called for the vote and the motion passed 4-1, with Vice Mayor Sochin in opposition.

Mayor Bell requested a correction to the May 18, 2016 Regular Town Council Minutes to rectify a spelling error under item 2A. A motion was made by Council Member Mixon, seconded by Vice Mayor Sochin, to approve the minutes as amended. Mayor Bell called for the vote, and the motion passed 5-0.

4. TOWN COUNCIL ANNOUNCEMENTS

Council Member Loyzelle requested Council approval to host an Alliance for Aging Community Conversations Workshop on June 27, 2016. The Council came to a general consensus to approve the workshop. Council Member Loyzelle reported on Circulator Bus efforts. Council Member Loyzelle also reported on a recently adopted Miami-Dade County Resolution allowing circulators on the busway and expanded on Town efforts associated with bus circulators and routes. Town Manager Rafael Casals provided additional information on efforts associated with bus routes.

Council Member Coriat announced the Lincoln City Park Community Input Meeting on July 9, 2016 and "The Big Sting: Mosquitos in South Florida" Educational and Community Outreach Workshop on July 14, 2016.

Council Member Mixon announced a Florida Fish and Wildlife Commission discussion on bear hunting on June 22, 2016, and spoke in opposition of bear hunting.

Mayor Bell reported on attendance at a recent South Dade Mayors Coalition Meeting. Mayor Bell announced the South Dade Solutions Summit Event on July 15, 2016, and the South A Municipal Advisory Committee Meeting on June 28, 2016. Mayor Bell reported on the Tri-City Hurricane Preparedness Workshop and thanked Town staff for their efforts. Mayor Bell also reported on a Cutler Bay Senior High School yearbook ad and graduation medallions provided by the Town in honor of the Cutler Bay Senior High School Inaugural Class and Commencement Ceremony.

5. PUBLIC COMMENTS

Mayor Bell reviewed the procedure for Public Comments. Mayor Bell opened Public Comments. Ms. Jean McJilton spoke on traffic study item 7C and expressed concern. Ms. Jean McJilton spoke in opposition of item deferrals. Mr. Marco Fernandez spoke in opposition of the 87th Avenue and Old Cutler Road project. Mr. Stephen Zarzecki spoke in opposition of traffic study item 7C and the traffic study methodology. Ms. Elizabeth Ott spoke in opposition of Quasi-Judicial items 9A through 9G.

There was discussion among the Council on the deferral of items. Mayor Bell closed Public Comments.

Town Manager Rafael Casals reported on the Annual 4th of July Spectacular at Black Point Park and Marina event and efforts with Miami-Dade County to allow golf cart access on the day of the event. Town Manager Rafael Casals provided a progress report on vacant property research in accordance with Town Resolution 16-25 adopted at the April 20, 2016 Regular Town Council Meeting. Town Manager Rafael Casals announced an awarded grant from Miami-Dade Metropolitan Planning Organization (MPO) for the Complete Streets Study Corridor Analysis. Town Manager Rafael Casals provided an update on the Florida Department of Transportation's (FDOT) Transportation Alternative Program grant application for the Manta Drive Roadway Improvement Project. Town Manager Rafael Casals announced the Department of Juvenile Justice (DJJ) selection of the Town to present the Afterschool Program before the Department of Juvenile Justice (DJJ) State Advisory Group (SAG). Town Manager Rafael Casals provided an update on Florida Green Building Coalition (FGBC) Certification, street light testing on Caribbean Boulevard, and on negotiations with Miami-Dade County to pair the Gap 2 Project with the Bridge project. At the request of Council Member Coriat, Town Manager Rafael Casals provided additional information on vacant property research.
