AMENDMENT NO. 4 TO EMERGENCY ORDER 20-04

The effects of COVID-19 continue to require extraordinary and immediate actions by the Town in order to further protect our residents' health, safety and welfare. The Town's parks and recreational facilities are potential gathering places for the spread of COVID-19. The data collected by the Florida Department of Health indicates the State has achieved several critical benchmarks in flattening the curve, including a downward trajectory of hospital visits for influenza-like illness and COVID-19-like syndromic cases, a decrease in percent positive test results, and a significant increase in hospital capacity since the issuance of Miami-Dade County Emergency Order No. ~~28-2029-20~~.

By virtue of the powers and duties vested in me as the Town Manager of the Town of Cutler Bay, Miami-Dade County, Florida, in accordance with Section 252.38 of the Florida Statutes, under Chapter 12, Article II, Sec. 12-23 (a) of the Town Code, and pursuant to the Town's Declaration of a State of Emergency issued on March 13, 2020, I hereby find that it will serve the health, safety and welfare of the residents of Cutler Bay to order the following:

All Town owned Parks and Recreational Facilities *shall remain* closed, except for:

The following Town owned Parks and Recreational Facilities with Sports Lighting shall be open: from 8:00 a.m. to 10:00 p.m.

- Lakes by the Bay Park | 8551 SW 216 Street
- Cutler Ridge Park | 10100 SW 200 Street
- **Saga Bay Park | Tennis Courts | 8000 SW 205 Street**

The following Town Owned Parks and Recreational Facilities shall be open: from 8:00 a.m. to 8:00 p.m.:

- Cutler Ridge Park | Pool | 10100 SW 200 Street

Limited Capacity & Hours	
Monday - Friday	
7:00 a.m. - 11:00 a.m.	Lap/Public Swim
4:00 p.m. - 8:00 p.m.	Swim Teams Only

- Blue Heron Park | 21900 SW 97 Avenue
- Lincoln City Park | SW 212 Street & SW 99 Avenue
- Saga Bay Park | 8000 SW 205 Street
- Saga Lake Park | SW 198 Street & SW 83 Avenue

The above referenced Parks and Recreational Facilities shall reopen subject to the restrictions set forth in Miami-Dade County Emergency Order No. 28-2029-20 and Center for Disease Control guidelines.

Notwithstanding the foregoing restrictions:

- All parks may be open only from the hours of 7 a.m. to 10 p.m. Within this time period, a park or recreational facility may be open for a shorter time period if prescribed by their normal operating hours or, with respect to parks operated by municipalities, by municipal regulation.
- Use of parks and recreational facilities shall be for limited active and passive uses by individuals and families, as permitted by this order and following current CDC and State Health Department guidelines.
- No groups of 10 or more persons shall congregate together in parks or recreational facilities. All persons, except for members of the same household, shall observe social distancing, both within groups and with others.
- Concessions and food trucks may operate in parks and marina parking lots as long as social distancing guidelines are followed.
- Limited active uses are allowed, including organized sports team activities, but competitions and league play are not permitted, except in the case of tennis, racquetball, softball and baseball, and if masks are worn by all players. Other organized sports team competitions, league play and scrimmages are not permitted. Bleachers shall not be open to spectators where organized sports team competitions and league play is permitted.
- To ensure that social distancing is maintained and to ensure access to facilities by patrons, parks staff may limit the number of persons using trails, paths, fields, or courts; and may limit the time any person spends on such trail, path, field, or court.
- Sports equipment shall not be shared. This does not apply to balls, and does not apply as between members of a household.
- Passive uses of parks are allowed if social distancing is maintained, provided, however, that table games and parties are prohibited.
- Selected park trails and walkways shall be one-way flow only, except where the existing configuration does not allow such flow. Where designated for one-way flow, persons shall only move in the designated direction.
- Facial coverings shall be worn at all times, in accordance with Emergency Order 20- 20, as amended, except where an exception to Emergency Order 20-20 applies.
- An attendant shall be provided for each restroom. Restrooms shall be cleaned no less than once every two hours with CDC approved products. Restroom use shall be one person or one household at a time.
- Vehicle parking capacity in parks shall be reduced by no less than 25 percent when practicable.

- Use of the following amenities is prohibited:
 - playgrounds and exercise equipment;
 - shelters;
 - splashpads; and
 - mechanical attractions.

- Water fountains shall remain closed as per Miami-Dade Emergency Order No. 28-20.

No person shall violate the terms of this Emergency Order, except upon direct authorization of the Town of Cutler Bay Police Department. Any violation of this Emergency Order shall be subject to fine, imprisonment, or both.

This Emergency Order shall be effective **commencing September 15, 2020 at 12:01 a.m. (EST)** and shall continue in effect from day-to-day until the State of Emergency issued on March 13, 2020 is declared to be terminated by the Town Manager or Town Council in accordance with Section 12-24 of the Town Code. This Emergency Order may be cancelled earlier by action of the Town Manager.
