

**RESOLUTION NO. 16-\_\_\_\_**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA URGING THE MIAMI-DADE COUNTY DEPARTMENT OF TRANSPORTATION AND PUBLIC WORKS TO CONDUCT A TRAFFIC STUDY OF THE CORRIDOR THAT CONSISTS OF S.W. 87<sup>th</sup> AVENUE BETWEEN S.W. 184<sup>th</sup> STREET AND S.W. 244<sup>th</sup> STREET EVALUATING THE SPEED LIMIT WITHIN THE AFOREMENTIONED CORRIDOR; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Cutler Bay (the “Town”) is concerned that the current speed limit in the corridor of S.W. 87<sup>th</sup> Avenue between S.W. 184<sup>th</sup> Street and S.W. 244<sup>th</sup> Street, (the “Corridor”) is unnecessarily high, and the existing posted speed limit on this roadway should be lowered to 30 MPH to protect pedestrians, cyclists, and wildlife; and

**WHEREAS**, the Town believes that a thorough evaluation of that Corridor should be conducted that would specifically consider decreasing the speed limit of said roadway; and

**WHEREAS**, the Town requests that the Miami-Dade County Department of Transportation and Public Works (“DTPW”) conduct a traffic study in order to determine whether a speed limit decrease is both possible and necessary in order to improve roadway safety; and

**WHEREAS**, the Town finds that this Resolution will promote the health, safety and welfare of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and are incorporated herein by this reference.

**Section 2. Request for Traffic Study.** The Town hereby requests that the DTPW conduct a traffic study on the Corridor to determine whether the speed limit can be reduced to 30 MPH to protect pedestrians, cyclists, and wildlife.

**Section 3. Effective Date.** This Resolution shall take effect immediately upon adoption.
