

**RESOLUTION NO. 18-\_\_**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AUTHORIZING THE TOWN MANAGER TO ISSUE A PURCHASE ORDER TO R.J. BEHAR & COMPANY, INC. FOR CONSTRUCTION ENGINEERING AND INSPECTION SERVICES FOR THE SAGA BAY 1.2 SUB-BASIN WATER QUALITY IMPROVEMENT PROJECT; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, on September 17, 2014, the Town of Cutler Bay (the “Town”) Town Council adopted Resolution No. 14-63, authorizing the Town Manager to negotiate and execute a Non-Exclusive Professional Services Agreement (the “Agreement”) to allow R.J. Behar & Company, Inc. (the “Consultant”), among others, to provide various engineering and architectural services for the Town; and

**WHEREAS**, in accordance with the terms of the Agreement and the provisions set forth in Resolution No. 14-63, the Public Works Department solicited a proposal from Consultant to provide construction engineering and inspection services (the “Services”) for the Saga Bay 1.2 Sub-Basin Water Quality Improvement Project (the “Project”); and

**WHEREAS**, Town staff has determined that Consultant would be the best suited to provide the Services for the Project; and

**WHEREAS**, Consultant has submitted a proposal to the Town for the Services for the Project in an amount not to exceed \$62,440.00, which is attached hereto and incorporated herein as Exhibit “A”; and

**WHEREAS**, the Town has budgeted for the Services for the Project within the 2017-18 Operating Budget and the Project will be funded from the Town's Stormwater Utility Funds; and

**WHEREAS**, the Town Council finds that this Resolution is in the best interest of the health, safety and welfare of the residents of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, THAT:**

**Section 1. Recitals.** The above recitals are true and correct and are incorporated herein by this reference.

**Section 2. Authorization.** In accordance with the terms and conditions of Resolution No. 14-63, the Town Council authorizes the Town Manager to issue a

purchase order to Consultant, in an amount not to exceed \$62,440.00, for the Services for the Project, as provided in Exhibit "A" attached hereto and incorporated herein.

**Section 3.** **Effective Date.** This resolution shall take effect immediately upon adoption.
