SMART Implementation Plan Charrettes

Transit supportive land use plays a critical role in the success of major rapid transit investments. The Miami-Dade TPO is now examining this interrelationship to complement the SMART Plan, which is intended to help achieve community goals through integrating transportation land use planning and development of strategies.

SMART Implementation Plan Charrettes

Two (2) series of charrettes will be conducted for the South Corridor, which runs from the Metrorail Dadeland South Station to Florida City (SW 344 Street). The first corridor charrette series will be conducted in December. Charrettes are intensive planning sessions where citizens, designers and others will be collaborating on a vision for the Corridor. The Charrettes will be organized to encourage the participation of everyone who is interested in the making of a vision for the Community: interested residents, business owners, associations, government, the development community and activists.
