

RESOLUTION NO. 15-____

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, RENAMING THE LAKES BY THE BAY LINEAR PARK, CONSISTING OF APPROXIMATELY 5.07 ACRES, TO “BLUE HERON PARK;” PROVIDING FOR AUTHORIZATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Cutler Bay (the “Town”) desires to create an identity for the recently acquired Lakes by the Bay Linear Park (the “Park”); and

WHEREAS, the Town Council, on May 15, 2013 via Resolution No. 13-31 accepted the conveyance of the approximately 5.07 acre Park from the Lakes by the Bay South Community Development District; and

WHEREAS, the Town’s Parks & Recreation Advisory Committee discussed the possible renaming of the Park and suggested that the Town’s Youth Council Committee provide the Parks & Recreation Advisory Committee recommended names; and

WHEREAS, the Youth Council Committee, during their regular Committee meeting, visited the Park and discussed possible names to differentiate the Park from the Town’s existing parks; and

WHEREAS, the Youth Council Committee unanimously approved and forwarded their recommendation to rename the Park “Blue Heron Park” to the Parks & Recreation Advisory Committee; and

WHEREAS, during the February 2015 Parks & Recreation Advisory Committee Meeting, the Committee unanimously voted to accept the Youth Council’s name recommendation of “Blue Heron Park;” and

WHEREAS, during the March 18, 2015 Town Council Meeting, the Parks & Recreation Advisory Committee Chairperson presented their recommendation of renaming the Park “Blue Heron Park;” and

WHEREAS, the Town Council finds that the renaming of the Park serves a valued public purpose and will provide residents of the Lakes by the Bay community with an identity for the Park.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Renaming of Park. The Town Council hereby renames the Park to Blue Heron Park.

Section 3. Authorization. The Town Manager is hereby authorized to take any and all steps necessary to implement the intent and purpose of this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
