

RESOLUTION NO. 16-_____

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AUTHORIZING THE TOWN MANAGER TO ISSUE A PURCHASE ORDER TO THE CORRADINO GROUP, INC. FOR THE PREPARATION OF THE COMPLETE STREETS CORRIDOR ANALYSIS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on November 20, 2013, the Town of Cutler Bay (the “Town”) adopted Resolution No. 13-92 approving the execution of Non-Exclusive Professional Services Agreements (the “Agreements”) to allow firms to provide various engineering and architectural services for the Town; and

WHEREAS, the Town was awarded a grant from the Metropolitan Planning Organization (the “MPO”) to perform the Cutler Bay Complete Streets Corridor Analysis; and

WHEREAS, the MPO grant award totaled \$50,000 and the Town will provide matching local funds totaling \$20,000; and

WHEREAS, in accordance with the terms of the Agreement and the provisions set forth in Resolution 13-92, the Public Works Department solicited a proposal from The Corradino Group, Inc. which has an executed Agreement with the Town; and

WHEREAS, The Corradino Group, Inc. successfully completed the Town’s 2010 and 2014 Transportation Master Plan, as authorized via Town Resolutions No. 08-34 and No. 13-46 respectively; and

WHEREAS, Town staff has determined that The Corradino Group, Inc. would be best suited to prepare the Cutler Bay Complete Streets Corridor Analysis because their selection would provide continuity and the Town would benefit from their existing understanding of the project; and

WHEREAS, Town staff has conducted preliminary negotiations with The Corradino Group, Inc. and estimated the cost of providing these services to the Town to be in the amount of \$70,000 (attached as Exhibit “A”); and

WHEREAS, the Town finds that this Resolution will promote the health, safety and welfare of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Authorization. In accordance with the terms and conditions of Resolution No. 13-92, which approved the execution of non-exclusive Professional Services Agreements to allow firms to provide various engineering and architectural services for the Town, the Town Manager is authorized, on behalf of the Town, to issue a Purchase Order in the amount of \$70,000 to The Corradino Group, Inc. for the preparation of the Cutler Bay Complete Streets Corridor Analysis, in substantially the form attached hereto as Exhibit "A".

Section 3. Effective Date. This resolution shall take effect immediately upon adoption.
