

**RESOLUTION 15-\_\_\_\_\_**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, ACCEPTING A FISCAL YEAR 2014-15 AND A FISCAL YEAR 2015-16 MINI-GRANT FOR DISTRACTED DRIVING PREVENTION, THROUGH THE FLORIDA DEPARTMENT OF HEALTH, INJURY PREVENTION PROGRAM (IPP) IN THE AMOUNT OF \$5,000 PER YEAR FOR A TOTAL OF \$10,000; AUTHORIZING THE TOWN MANAGER TO ACCEPT THE GRANT, AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Cutler Bay applied for and received the FY 2013-14 Mini-Grant for Distracted Driving Prevention from the Florida Department of Health (the “Department”), Injury Prevention Program (IPP) in the amount of five thousand dollars (\$5,000); and

**WHEREAS**, the grant was offered by the Department, Injury Prevention Program (IPP) through funding appropriated by the Centers for Disease Control and Prevention (CDC), National Center for Injury Prevention and Control pursuant to the authority of SEC 301, 317 & 391A, 42 USC 241, 247B & 280B-B3 and per Section 401.243, F.S.; and

**WHEREAS**, this grant was renewable for up to three years (FY 2014-15 and FY 2015-16) contingent upon the availability of funding and contract performance; and

**WHEREAS**, the Town has successfully met the goals and objectives of the grant contract for FY2013-14 and was awarded \$5,000 to continue the Distracted Driving Prevention program during FY2014-15; and

**WHEREAS**, the Town has gone above and beyond meeting the goals and objectives of the grant contract for FY2014-15 and has been awarded \$5,000 to continue the Distracted Driving Prevention program during FY2015-16; and

**WHEREAS**, the Town Council authorizes the Town Manager to accept the grant awards to continue the Distracted Driving Prevention program, which raises awareness about the dangers of driving while distracted; and

**WHEREAS**, the Town finds that this resolution will promote the health, safety and welfare of the Town.

**NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals Adopted.** That each of the above stated recitals is hereby adopted and confirmed.

**Section 2. Grant Accepted and Authorization.** The Town Council accepts the grants and authorizes the Town Manager to continue to implement a Distracted Driving Prevention Program Mini-Grant, substantially in the form attached hereto as Exhibit "A," that will raise awareness about the dangers of driving while distracted.

**Section 3. Effective Date.** This resolution shall become effective immediately upon adoption.
