

RESOLUTION NO. 16-__

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AUTHORIZING THE TOWN MANAGER TO ISSUE A PURCHASE ORDER TO ENVIROWASTE SERVICES GROUP, INC. FOR TOWNWIDE SIDEWALK REPAIRS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Council authorized the issuance of the Invitation to Bid (“ITB”) number 13-09 for the replacement and installation of sidewalks; and

WHEREAS, the ITB resulted in eight (8) bids being received prior to the January 16, 2014 deadline; and

WHEREAS, the Town Council on February 19, 2014 adopted Resolution number 14-07 (attached hereto as Exhibit “A”), selecting the first ranked firm, Envirowaste Services Group, Inc., to provide services identified in ITB number 13-09; and

WHEREAS, pursuant to the ITB competitive selection process utilized by the Town and the recommendation of the Town Manager, the Town Council desires to utilize the services of the first ranked firm, Envirowaste Services Group, Inc. (the “Contractor”), to continue to provide for the replacement and installation of sidewalks for the 2016-17 fiscal year; and

WHEREAS, the Town’s Public Works Department has identified sidewalks throughout the Town in need of replacement, as per the Town’s 2009 Sidewalk and Roadway Assessment Report; and

WHEREAS, funding for the sidewalk replacements are allocated within the Public Works Department’s 2016-17 Operating Fund; and

WHEREAS, the Town Council finds that adopting this Resolution is in the best interest and welfare of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

Section 1. **Recitals.** The above recitals are true and correct and are incorporated herein.

Section 2. **Authorization.** The Town Manager is hereby authorized to issue a Purchase Order, in accordance with Exhibit “A,” in an amount not to exceed \$275,000 to Envirowaste Services Group, Inc., for purposes of providing sidewalk repairs and installations within the Town for the 2016-17 fiscal year.

Section 3. **Effective Date.** This Resolution shall be effective immediately upon adoption.
