

## RESOLUTION 17-04

### **A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, APPOINTING AND REAFFIRMING MEMBERS TO THE TOWN OF CUTLER BAY COMMITTEES; APPOINTING TOWN COUNCIL LIAISONS TO THE COMMITTEES; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Cutler Bay (the "Town") Town Council (the "Council") has created the Community for a Lifetime Committee, the Economic Growth Committee, the Education Advisory Committee, the Floodplain Mitigation Plan Committee, the Parks and Recreation Committee, and the Youth Council Committee (collectively, the "Committees"); and

**WHEREAS**, in accordance with Ordinance 11-08 13-01, the Council wishes to appoint or reappoint members to the Committees and appoint Committee liaisons to the Council; and

**WHEREAS**, the Council finds that this Resolution is in the best interest of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and are incorporated herein by this reference.


**Section 2. Appointment and Reaffirmation of Committee Members.** The Council hereby appoints and reaffirms the committee members listed in Exhibit "A" attached hereto and incorporated herein to serve as members of the respective Committees.

**Section 3. Appointment and Reaffirmation of Town Council Liaisons.** The Council hereby appoints Council Member Roger Coriat as the Town Council Liaison to the Education Advisory Committee; Council Member Michael Callahan as the Town Council Liaison to the Parks and Recreation Committee; and Mayor Peggy Bell and Council Member Mary Ann Mixon as Co-Liaisons to the Youth Council Committee. The Council reaffirms the appointments of Vice Mayor Sue Ellen Loyzelle as the Town Council Liaison to the Community for a Lifetime Committee, Mayor Peggy Bell as the Town Council Liaison to the Economic Growth Committee and Council Member Mary Ann Mixon as the Town Council Liaison to the Floodplain Mitigation Plan Committee.


**Section 4. Term of Service Limits.** Members appointed to Town Committees as listed in Exhibit "A" shall serve for not more than eight (8) consecutive years on any one committee. The eight (8) year Term of Service Limit shall begin upon adoption of this resolution. A one (1) year separation from service from that committee is required before the committee member is eligible for service to that committee again.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
