A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, SUPPORTING THE MIAMI-DADE COUNTY PUBLIC SCHOOL BOARD'S 2017 STATE LEGISLATIVE PROGRAM; PROVIDING FOR TRANSMITTAL; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in April 2012, the Town of Cutler Bay (the "Town") Town Council adopted Resolution No. 12-21 approving an Interlocal Agreement with the Miami-Dade County Public School ("MDCPS") Board for the purpose of establishing additional education choices within the Town; and
