

**RESOLUTION NO. 17-\_\_**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL  
OF THE TOWN OF CUTLER BAY, FLORIDA,  
SUPPORTING THE MIAMI-DADE COUNTY PUBLIC  
SCHOOL BOARD'S 2017 STATE LEGISLATIVE  
PROGRAM; PROVIDING FOR TRANSMITTAL; AND  
PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, in April 2012, the Town of Cutler Bay (the "Town") Town Council adopted Resolution No. 12-21 approving an Interlocal Agreement with the Miami-Dade County Public School ("MDCPS") Board for the purpose of establishing additional education choices within the Town; and

**WHEREAS**, the Town desires to express its support of MDCPS' 2017 State of Florida Legislative Program; and

**WHEREAS**, the MDCPS Board has approved a state legislative program, encouraging the Florida legislature to fund several key measures related to public schools in the district; and

**WHEREAS**, the state legislative program addresses key measures such as student safety and wellness, facilities, virtual education, and teacher shortages; and

**WHEREAS**, the Town Council deems it to be in the best interest and welfare of the residents of the Town to support the MDCPS Board 2017 State of Florida Legislative Program.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:**

**Section 1.**     **Recitals.** The above recitals are true and correct and are incorporated herein by this reference.

**Section 2.**     **Support.** The Town Council hereby expresses its support of the Miami-Dade County Public School Board 2017 State Legislative Program as further provided in Exhibit "A".

**Section 3.**     **Transmittal by Clerk.** The Town Clerk is hereby directed to transmit this Resolution to the Miami-Dade County Legislative Delegation, Miami-Dade County Public School Board, and the Miami-Dade County League of Cities.
