A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AUTHORIZING THE TOWN MANAGER TO NEGOTIATE AND ISSUE AN ADDITIONAL PURCHASE ORDER TO KIMLEY HORN & ASSOCIATES, INC. FOR THE TOWN CENTER PLAZA CONSTRUCTION PLANS AND FINAL DESIGN SERVICES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on April 20, 2016, the Town adopted Resolution No. 16-27 authorizing the Town Manager to issue a purchase order to the Consultant, for professional engineering and design services for the Town Center Plaza Conceptual Plans Design and Cost Estimate Services; and

WHEREAS, the following Public Involvement Meetings were held: May 31, 2016, June 28, 2016, July 26, 2016, August 30, 2016, and October 11, 2016; and

WHEREAS, during the Regular Town Council Meeting on January 18, 2017, the Consultant provided a summary of the five (5) Public Involvement Meetings; and

WHEREAS, the Consultant has successfully completed the Scope of Services outlined in RFQ No. 15-06 and has provided the final report dated January 18, 2017, attached hereto as Exhibit "A"; and

WHEREAS, as a result of the five (5) Public Involvement Meetings, the Town Council desires to expedite the development of the construction design plans; and

WHEREAS, the Town Council wishes to authorize the Town Manager to negotiate and issue an additional purchase order with Consultant for the Town Center Plaza Construction Plans and Final Design Services in accordance with Section VIII of the Professional Services Agreement between the Town and Consultant dated April 20, 2016; and

WHEREAS, the Town Council finds that this Resolution is in the best interest of the Town.
