# MEMORANDUM

**To:** Honorable Mayor and Town Council

**From:** Rafael G. Casals, Town Manager

**Date:** July 20, 2016

**Re:** Vacant Land Study

---

The Town mailed a total of 258 letters dated April 29, 2016 to the property owners of the vacant properties within the Town. The letter requested the owners answer the following questions:

- What is the status of your vacant property?
- Are there any future plans for developing your vacant property?
- If the property is planned for future development, what type of proposed uses, form and functions of proposed buildings?
- Is the vacant property for sale or will it be placed for sale in the near future?

A follow-up letter dated June 21, 2016 was mailed to the 152 property owners who had not responded as of June 20, 2016 requesting the same information as above.

As of, July 20, 2016, the Town has received responses for one hundred thirty-four (134) property owners. Of the one hundred thirty-four (134) property owners who responded, one hundred sixteen (116) of the properties are currently not for sale and seeking possible future developments and eighteen (18) are currently for sale.
