RESOLUTION 17-18

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, ACCEPTING A 2017 NEAT STREETS MIAMI STREET TREE MATCHING GRANT AWARD; PROVIDING FOR AUTHORIZATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Cutler Bay ("Town") applied for the 2017 Neat Streets Miami Street Tree Matching Grant Program from Miami-Dade County for purposes of implementing the Cutler Bay Streetscape Enhancement project; and

WHEREAS, Miami-Dade County engages municipalities, non-profits and community organizations in planting native or Florida-friendly trees on Miami-Dade's corridors and gateways, and awarded the Town a fiscal year 2017 grant in the amount of twelve thousand five hundred dollars (\$12,500) (the "Grant"); and

WHEREAS, the Town Council desires to accept the Grant from Miami-Dade County as provided for by the Tree Planting Agreement (the "Grant Agreement"), attached hereto as Exhibit "A;" and

WHEREAS, the Town Council finds that adopting this Resolution is in the best interest and welfare of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

Section 1. <u>Recitals.</u> That the recitals above are true and correct and are incorporated herein by this reference.

<u>Section 2.</u> <u>Grant Accepted.</u> The Town Council accepts the Grant from Miami-Dade County in the amount of twelve thousand five hundred dollars (\$12,500), as provided for by the Grant Agreement, attached hereto as Exhibit "A."

<u>Section 3.</u> <u>Authorization.</u> The Town Council hereby authorizes the Town Manager to execute the Grant Agreement in substantially the same form attached hereto as Exhibit "A," subject to the Town Attorney's approval as to form, content and legal sufficiency.

Section 4. Effective Date. This Resolution shall become effective immediately upon adoption.

TREE PLANTING AGREEMENT

Grantee: Town of Cutler Bay

Amount: \$12,500

Grant Period: 5/16/17 - 8/31/17

Grant Description: To plant trees with municipalities and organizations on Miami-Dade's corridors as part of our efforts to reach the Million Trees Miami goal of planting 1 million trees and reaching a 30% tree canopy by 2020.

This **Agreement (the "Agreement")**, made and entered into this <u>I</u> day of <u>March</u>, 20<u></u>, by and between <u>Town of Cutler Bay</u> (the "Grantee") and Miami-Dade County (the "County"), hereinafter called the "County" through its Parks, Recreation, Open Spaces Department (the "Department").

The County and Grantee have agreed to partner on the implementation of <u>Cutler Bay Streetscape Enhancement</u> (project name) to be completed in August 31, 20<u>17</u>.

RECITALS

WHEREAS, the County desires to increase the tree canopy in Miami-Dade County and to reach the Million Trees Miami goal of planting 1 million trees and a 30% tree canopy by 2020; and

WHEREAS, the County has provided a subaccount to the tree trust fund for the procurement of street trees along county and local roads and of this amount $\frac{12,500}{12,500}$ (the "Grant Funds") will be provided to the Grantee on the terms and conditions set forth in this Agreement; and

WHEREAS, the Grantee wishes to undertake such activities provided in the scope of work in Exhibit A of this Agreement; and

WHEREAS, the Grantee is responsible for the maintenance of the street trees after completion of the project; and

NOW, THEREFORE, the County and Grantee agree as follows:

TERMS AND CONDITIONS OF AGREEMENT

- A. Requirements for approval of Grant Award Agreement: As a prerequisite to its receipt of the Grand Funds, the Grantee shall meet the requirements set forth below to the County's satisfaction. Requirements for this grant are listed below.
 - 1. **Timeline:** The following grant project start date, end date and reporting dates must be adhered to.

Start date: _Contract Execution Date End date: _August 31, 2017_____ Final report date: _September 30, 2017_____

- 2. Scope of Work: It is mutually agreed and understood that the scope of work shall be as provided in *Exhibit A*.
- 3. **Budget:** It is mutually agreed and understood that the project costs shall be as provided in *Exhibit B*. The match amount has to equal or exceed the grant amount. If matching requirement will be met through the provision of in-kind service, the County shall approve the value or cost or the in-kind services to be provided to fulfill the matching requirements. Match must remain the same or exceed the percent referenced in the original application.
- 4. Promotions: The grantee will agree to prepare a draft of a Press Release which describes its project and acknowledges Neat Streets Miami and Million Trees Miami, which shall be subject to the County's approval in advance of publication. The County shall also be acknowledged in any subsequent media releases or in any printed, website, social media or other communication materials related to the project. Copies of any other publicity as well as copies of any major work products generated in connection with this grant shall forwarded to the County for review. The Miami-Dade, Million Trees Miami and Neat Streets Miami logos should be included in all printed materials. Please include the following copy in the Press Release:

About Million Trees Miami and Neat Streets Miami

Launched by <u>Neat Streets Miami</u>, the <u>Million Trees Miami</u> Campaign is a communitywide effort to plant one million trees by 2020 in order to achieve a 30 percent tree canopy cover for Miami-Dade County. Neat Streets Miami is a multi-jurisdictional county board dedicated to the maintenance and beautification of transportation corridors, gateways and connections.

5. Conditions and Contingencies: The Grantee agrees that the Grant Funds will be used only for the purpose as stated in this Agreement, as described in the Scope of Work (*Exhibit A*) and with no substantial variance to the approved Budget (*Exhibit B*) unless prior approval in writing is obtained from the County. The Grantee certifies that the grantee organization operates under a tax-exempt status. If grantee determines that Grant Funds cannot be expended by August 31, 2017, the grantee must notify liaison immediately and no later than <u>May 31, 2017</u>.

B. Additional Requirements due throughout the funding period:

- 1. **Evaluation Consultant:** The Grantee may be required to work with an evaluation consultant who will be assigned by the County.
- 2. **Reporting:** Final Report must be submitted electronically 30 days following the completion of the grant period. Refer to Exhibit C for reporting guidelines.
- 3. Data Tracking: All trees planted must be mapped according to County specifications.
- 4. Organizational Status Changes: The Grantee must notify the County liaison within two weeks of changes in organizational status, including but not limited to: key personnel such as senior or project staff, organizational name, tax status, and organizational address.
- 5. **Other Organizational Changes**: The Grantee will notify the County's liaison of any organizational changes, such as new address or contact information

C. Indemnification of County

The Grantee agrees to indemnify, save, and hold the County harmless from all liability, loss, cost, and expense, including attorneys' fees and court costs at all trial and appellate levels, which may be sustained by the County, to any person, natural or artificial, by reason of the death of or injury to any person or damage to any property, whether or not due to or caused by the negligence of the Grantee, arising from or in connection with the Grantee's (or its employees, agents, contractors, subcontractors, licensees, or invitees) installation and/or maintenance of trees on County property or in the County right-of-way. The Grantee agrees to defend, at its sole cost and expense, but at no cost and expense to the County, any and all suits or actions instituted against the County for the imposition of such liability, loss, cost, and expense arising from or in connection with the Grantee's subcontractors, licensees, or its employees, agents, contractors, subcontractors for the imposition of such liability, loss, cost, and expense arising from or in connection with the Grantee's (or its employees, agents, contractors, subcontractors, licensees, or invitees) installation and/or maintenance of trees on county property or in the Grantee's (or its employees, agents, contractors, subcontractors, licensees, or invitees) installation and/or maintenance of trees on County property or in the Grantee's (or its employees, agents, contractors, subcontractors, licensees, or invitees) installation and/or maintenance of trees on County property or in the County right-of-way.

EXHIBIT A GRANT WORK PLAN

PROJECT TITLE: Cutler Bay Streetscape Enhancement Project

PROJECT LOCATION: The Town will plant thirty-five (35) native Florida Grade #1 Trees along local Town and Miami-Dade County Roads in the public right-of-ways throughout the Town. See Attachment "A" for the Cutler Bay Tree Plan.

MAINTENANCE PLAN: The Town's landscaping contractor along with our Public Works Department will be responsible for the maintenance of the trees. Street teams monitor the Town's landscaping daily to ensure the health of trees and plants. Regular landscaping includes; tree uplifting for street and pedestrian clearance, fertilizer application, pesticide application and weed control in accordance with Florida Friendly Yards' Best Management Practices.

PROJECT OUTCOMES: The primary beneficiaries of this project will be residents living in residential communities throughout the Town with limited tree canopy. The Town maintains a list of areas where there is a gap in tree canopy based on regular monitoring from Town Staff and requests from Town residents. The project has two goals: (1) Improve Canopy/Plant Additional Trees: The Town will demonstrate proper urban forestry principles and improve the quality of life for residents in an area with a lack of street trees.; and (2) Educate property owners about proper Tree Selection, Planting and Maintenance.

Cutler Bay has been a Tree City USA designee since 2009 and has received the Tree Growth Award, each year since 2012. Since adopting our Tree Master Plan in 2009, we have seen our Tree Canopy double. Our goal is to have a tree inventory of over 6,700 trees, and we have planted approximately 3,000 to date. This project will advance the community's tree strategy by increasing the overall tree canopy of our community and educating residents and business owners about the importance of urban forestry.

EDUCATION PLAN/COMMUNITY ENGAGEMENT: The Town provides tree planting and maintenance education to the public in accordance with our Tree Beautification Ordinance. The Town prints educational brochures/flyers developed by the University of Florida's IFAS Horticultural Extension Center, and distributes the material door-to-door to residents prior to all tree planting/maintenance activities. This information is also available on the Town's website.


The Town's Public Works Director and Certified Arborist, Alfredo Quintero is also available to provide property owners with one-on-one consultation about proper planting and pruning trees. In addition to distributing educational material door to door to residents directly impacted by this project, the Town hosts annual Tree Planting Ceremonies in celebration of Arbor Day and/or Earth Day. The Town has purchased the center page of the Cutler Bay Community Newspaper, which allows the Town to highlight special projects and activities one time a month in a full color news spread. The Town will use this opportunity to feature the Cutler Bay Streetscape Project; educating residents about the benefits of street trees and canopy, and promoting the County's efforts to plant 1 Million Trees by 2020.


