



## TOWN OF CUTLER BAY **TERMINATION OF** DECLARATION OF STATE OF EMERGENCY

A State of Emergency was declared by Governor Rick Scott of the State of Florida, Executive Order No. 17-235 effective at 11:00 AM on September 4, 2017 and by Mayor Carlos Gimenez of Miami-Dade County effective at 12:30 PM on September 5, 2017. President Donald J. Trump also declared a State of Emergency for Florida effective on September 4, 2017.

As Town Manager of the Town of Cutler Bay, I, Rafael G. Casals, exercised the authority given me under Chapter 12, Article II, Sec. 12-23 (a) of the Town Code, and declared a State of Emergency for the Town of Cutler Bay, on Wednesday, September 6, 2017.

Following the impact of Hurricane Irma, Town Staff worked diligently to protect life, property, and public infrastructure and provide emergency assistance as necessary. Town Hall offices have been opened and operations will continue as normal. Streets have been cleaned, power has been restored, and residents have been sent home safely.

Pursuant to Chapter 12, Article II, Sec. 12-24 of the Town Code, the State of Emergency for the Town of Cutler Bay has been terminated as of **Monday, September 18, 2017 at 7:00 AM**, as conditions causing the emergency no longer exist and the Town's departments are able to manage the situation without extraordinary assistance.
