A RESOLUTION OF THE MAYOR AND TOWN COUNCIL THE TOWN OF **CUTLER** BAY, FLORIDA, ACCEPTING A GRANT FROM THE **FLORIDA** DEPARTMENT OF ENVIRONMENTAL PROTECTION; APPROVING A GRANT AGREEMENT (CONTRACT NO. NS023) FOR STORMWATER RETROFIT; PROVIDING FOR AUTHORIZATION; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Town of Cutler Bay (the "Town") has submitted a request for funding to the Florida Department of Environmental Protection ("FDEP") Total Maximum Daily Load Water Quality Restoration Grant (the "Grant"); and

**WHEREAS**, FDEP notified the Town that it has been awarded a grant of \$374,000.00; and

**WHEREAS**, the Grant funding supports the SW 100 Avenue Stormwater Retrofit Project (the "Stormwater Project"), which is located within the Point Royale Section 5 Sub-Basin from Broad Channel Drive to SW 186th Street; and

**WHEREAS,** the Town Council desires to accept the Grant and authorize the Town Manager to execute FDEP Agreement No. NS023 for award of the stormwater improvement funds to the Town ("Agreement"), which is attached hereto as Exhibit "A" and made part hereof; and

**WHEREAS**, the Town Council finds that the adoption of this Resolution is in the best interest and welfare of the residents of the Town.

## NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:
