

RESOLUTION NO. 18-____

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, ADOPTING A TRAFFIC CALMING MASTER PLAN; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Cutler Bay (the “Town”) desires to create livable, safe and connected streets with an efficient, multimodal transportation network that promotes the health and mobility of all citizens and visitors of all ages and abilities while reducing the negative impacts on the environment; and

WHEREAS, on October 15, 2014, The Town Council adopted Resolution No. 14-71, adopting the Town’s 2014-19 Strategic Master Plan, which includes Goal No. 6.2- to optimize the smooth flow of traffic through the Town by minimizing traffic congestion and maximizing the capacity of local roadways; and

WHEREAS, on May 18, 2016, the Town Council adopted Resolution No. 16-30, authorizing Marlin Engineering, Inc. (the “Consultant”) to develop the Town’s Traffic Calming Master Plan (the “Master Plan”); and

WHEREAS, the Consultant held several public meetings with Town staff and a series of public involvement meetings/workshops for the Town and its residents between the months of September 2016 and May 2017; and

WHEREAS, the Consultant incorporated the feedback from Town staff and residents’ comments, and subsequently presented the final draft of the Master Plan attached hereto as Exhibit “A;” and

WHEREAS, the Town recognizes the Town’s growing population will require the efficient use of all public rights-of-way, which balances all modes of transportation and meets the needs of people of all ages and abilities; and

WHEREAS, the Town recognizes the importance of being proactive in developing a greener, healthier, aesthetically pleasing, dynamic, vibrant, and cosmopolitan community; and

WHEREAS, the Town Council finds that the adoption of the Master Plan is in the best interest of the health, safety and welfare of the residents of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, THAT:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Adoption of the Master Plan. The Town Council hereby adopts the Master Plan, in substantially the form attached hereto as Exhibit "A."

Section 3. Implementation. The Town Council authorizes the Town Manager to take all actions necessary to implement the projects identified in the Master Plan.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
