

**RESOLUTION NO. 18-\_\_\_\_\_**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL  
OF THE TOWN OF CUTLER BAY, FLORIDA,  
APPOINTING A MEMBER TO THE ECONOMIC GROWTH  
COMMITTEE; AND PROVIDING FOR AN EFFECTIVE  
DATE.**

**WHEREAS**, on May 20, 2015, the Town of Cutler Bay (the “Town”) Town Council (the “Council”) adopted Resolution No. 15-37 creating the Economic Growth Committee (the “Committee”) to advise the Town Council with regard to marketing, attracting new business and supporting existing businesses; and

**WHEREAS**, on December 14, 2016, the Town Council adopted Resolution No. 16-65 extending the existence of the Committee; and

**WHEREAS**, there is a vacancy on the Committee due to the resignation of Council Member Coriat's appointment to the Committee; and

**WHEREAS**, section 2-269 of the Town’s Code provides the procedure for filling a board or committee vacancy; and

**WHEREAS**, the Council desires to appoint a new member to fill the vacancy on the Committee; and

**WHEREAS**, the Town Council finds that the adoption of this Resolution is in the best interest of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL  
OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:**

**Section 1.**     **Recitals.** The above recitals are true and correct and are incorporated herein.

**Section 2.**     **Appointment of Committee Member.** The Town Council hereby appoints a Committee member to fill a vacancy as shown on Exhibit “A” attached hereto and incorporated herein.

**Section 3.**     **Effective Date.** This Resolution shall take effect immediately upon adoption.
