## **RESOLUTION NO. 18-\_\_\_**

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, FORMALLY REQUESTING THAT THE MIAMI-DADE COUNTY BOARD OF COUNTY COMMISSIONERS **RENAME THE SEGMENT OF S.W. 211 STREET/CUTLER RIDGE BOULEVARD BETWEEN S.W. 107 AVENUE AND** S.W. 112 AVENUE AS CUTLER BAY BOULEVARD; PROVIDING FOR TRANSMITTAL; PROVIDING FOR **AUTHORIZATION;** AND PROVIDING FOR AN **EFFECTIVE DATE.** 

WHEREAS, the Town of Cutler Bay (the "Town") Council wishes to rename the segment of S.W. 211 Street/Cutler Ridge Boulevard between S.W. 107 Avenue and S.W. 112 Avenue to Cutler Bay Boulevard to continue creating a sense of identity and community in Cutler Bay; and

**WHEREAS**, at the January 17, 2018 Town Council Meeting, the Youth Council and the Economic Growth Committees presented advisory recommendations in favor of renaming S.W. 211 Street/Cutler Ridge Boulevard to include the name "Cutler Bay;" and

**WHEREAS**, both advisory presentations stated that renaming S.W. 211 Street/Cutler Ridge Boulevard would further the Town's efforts to enhance its identity and brand; and

**WHEREAS**, the Town Council deems it to be in the best interest and welfare of the Town to rename the segment of S.W. 211 Street/Cutler Ridge Boulevard between S.W. 107 Avenue and S.W. 112 Avenue as Cutler Bay Boulevard.

## NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA AS FOLLOWS:

Section 1. <u>Recitals</u>. The above Recitals are true and correct and incorporated herein by this reference.

Section 2. <u>Request</u>. The Town Council hereby requests that the Miami-Dade County Board of County Commissioners rename the portion of S.W. 211 Street/Cutler Ridge Boulevard, between S.W. 107 Avenue and S. W. 112 Avenue, as Cutler Bay Boulevard.

<u>Section 3.</u> <u>Transmittal</u>. The Town Council hereby directs the Town Clerk to transmit a certified copy of this Resolution to the Miami-Dade County Board of County Commissioners for its consideration.

Section 4. <u>Authorization of Town Manager</u>. The Town Manager is hereby authorized to take any and all steps necessary implement the intent and purpose of this

Resolution, including, but not limited to, the execution of any required documents on behalf of the Town that will bring the aforementioned goal to fruition.

Section 5. Effective Date. This Resolution shall be effective immediately upon adoption.
