A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, APPROVING THE CONTRACT BETWEEN THE CHILDREN'S TRUST AND THE TOWN FOR THE PROVISION OF AN AFTER-SCHOOL PROGRAM AT CUTLER RIDGE PARK; PROVIDING FOR AUTHORIZATION; AND PROVIDING FOR AN EFFECTIVE DATE.

- **WHEREAS,** the Children's Trust (the "Trust") is a dedicated source of revenue established by voter referendum to improve the lives of children and families in Miami-Dade County (the "County"); and
- **WHEREAS,** the Trust provides funding for organizations to provide out-of-school programs throughout the County; and
- **WHEREAS,** the Town of Cutler Bay (the "Town") has been selected by the Trust as a recipient of funding for the "Cutler Bay After-School Program" for children in kindergarten through fifth grade (the "Program"); and
- **WHEREAS**, the Trust and Town's staffs have worked together on the details of the scope of services and budget for the Trust-funded portion of the Town's program; and
- **WHEREAS,** the Town Council desires to accept the Trust funding and authorize the Town Manager to execute a contract and any subsequent annual renewals (the "Contract") with the Trust, which Contract is attached hereto as Exhibit "A"; and
- **WHEREAS**, the Town Council finds that this Resolution is in the best interest and welfare of the Town.

## NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

- **Section 1. Recitals.** The above recitals are true and correct and are incorporated herein by this reference.
- **Section 2. Approval**. The Town Council approves the funding provided by the Trust and the Contract in substantially the form attached hereto as Exhibit "A."
- **Section 3. Authorization.** The Town Manager is authorized to execute the Contract, and any subsequent annual renewals, in substantially the form attached hereto as Exhibit "A," on behalf of the Town, subject to the approval of the Town Attorney as to form, content and legal sufficiency.

**Section 4. Effective Date**. This Resolution shall become effective immediately upon adoption.
