A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, APPROVING A SUBRECIPIENT AGREEMENT WITH THE FLORIDA DEPARTMENT OF AGRICULTURE AND CONSUMER SERVICES FOR THE CUTLER RIDGE PARK LIGHTING ENHANCEMENT PROJECT; PROVIDING FOR AUTHORIZATION; AND PROVIDING FOR AN EFFECTIVE DATE.

- <u>Section 3.</u> <u>Authorization of the Town Manager.</u> The Town Manager is hereby authorized to take all actions necessary to enter into the Subrecipient Agreement for the "Cutler Ridge Park Lighting Enhancement Project" with FDACS in substantially the form attached hereto as Exhibit "A" for the Town, subject to the Town Attorney's approval as to form, content and legal sufficiency.
- **Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
