

RESOLUTION NO. 18-__

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL
OF THE TOWN OF CUTLER BAY, FLORIDA,
APPROVING A VARIANCE APPLICATION FOR PUBLIX
SUPERMARKETS, EAST OF OLD CUTLER ROAD, WEST
OF SW 92ND PLACE, NORTH OF SW 212 STREET, AND
SOUTH OF SW 208TH STREET, TO PERMIT THREE (3)
WALL SIGNS WHERE ONE (1) IS PERMITTED; AND
PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, Publix Supermarkets, Inc. (the “Applicant”) has submitted a variance application to vary the permanent sign requirements in Section 3-114(b) of the Town Code relating to the number of wall signs permitted along Old Cutler Road to permit three (3) wall signs where only one (1) is permitted; and

WHEREAS, the proposed commercial mixed-use development will be built along the Old Cutler Road corridor between SW 212 Street and SW 208 Street on property zoned NC-1, as legally described in Exhibit “A”; and

WHEREAS, on February 23, 2018, the Applicant submitted a new development application to the Town for conditional use, variance, and site plan approvals; and

WHEREAS, public notice was provided in accordance with law; and

WHEREAS, after a duly noticed public hearing, the Town Council, based upon competent substantial evidence in the record, finds that the application meets the requirements of the Town Code and is consistent with the Town’s Comprehensive Plan; and

WHEREAS, the Town Council finds that this Resolution is in the best interest and welfare of the residents of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

Section 1. **Recitals.** The above recitals are true and correct and are incorporated herein by this reference.

Section 2. **Approval.** The Town Council, after review of competent substantial evidence in the record and a duly noticed public hearing, hereby approves the variance application to allow three (3) wall signs where one (1) is permitted per Section 3-114(b) of the Town Code, and finds that it meets the standards set forth in Section 3-36 of the Town Code.

Section 3. **Violation.** Failure to adhere to the terms of this approval shall be considered a violation of the Town Code. Penalties for such violation shall be as prescribed by the Town Code, which include, but are not limited to, the revocation of the approval granted by this Resolution.

Section 4. **Effective Date.** This Resolution shall take effect immediately upon adoption.
