



FY2018 Edward Byrne Memorial Justice Assistance Grant (Countywide)

The Edward Byrne Memorial Justice Assistance Grant (JAG) Program (42 U.S.C. 3751(a)) provides states and units of local governments with critical funding necessary to support a range of program areas including law enforcement, prosecution and court programs, prevention and education programs, corrections and community corrections, drug treatment and enforcement, crime victim and witness initiatives, and planning, evaluation, and technology improvement programs. Funding allocations are determined by a statutory formula compiled by the US Department of Justice. The Town receives two allocations that are passed through from the Department of Justice to the Florida Department of Law Enforcement and/or Miami-Dade County. *The allocation that the Town receives from the County for fiscal year 2018 is \$4,939.*

PROJECT BACKGROUND:

The Town of Cutler Bay's Policing Unit desires to use the \$4,939 allocation for prevention education. The Cutler Bay Youth Safety Program allows officers to continue outreach efforts at local after-school programs, summer camps, schools, and community events. The Neighborhood Resource Unit (NRU) will purchase educational and promotional material on topics such as bully prevention, personal safety, online safety, bicycle/pedestrian safety and more. In response to public feedback about bicycle theft, officers will also purchase and distribute bicycle locks upon request and during bicycle related community events. By September 30, 2019, Officers will reach approximately 1,000 residents by;

- Making three (3) safety presentations at youth programs, schools, or HOA meetings.
- Attending four (4) community events/public meetings to distribute educational and promotional material.
- Placing educational material at key locations around Town (i.e. Town Hall lobby, Southland Mall, Youth Programs, Apartment Complexes).
- Attending one (1) bike safety event to distribute bike locks and bicycle/pedestrian safety information.
