## 1. CALL TO ORDER, ROLL CALL, PLEDGE OF ALLEGIANCE, & MOMENT OF SILENCE

Council Member Coriat announced a rescheduled date of October 11th for the Education Advisory Committee.

Council Member Mixon announced the Floodplain Mitigation Plan Committee Meeting on September 27th, and explained the possibility of a thirty percent discount on flood insurance for Town residents.

Vice Mayor Loyzelle announced the Senior Games taking place October 15th through the 19th, and also announced a vacancy on the Communities For a Lifetime Committee.

Town Clerk Debra Eastman read the title of the Ordinance.

Mayor Bell made an amendment to the Ordinance stating that prior to issuance of any permit, including plumbing and electrical, that the covenant shall be executed by the owner.

Mayor Bell opened the Public Hearing. There being no one wishing to speak, Mayor Bell closed the Public Hearing.

A motion was made by Council Member Mixon, seconded by Council Member Coriat, to adopt the Ordinance as amended.

Town Attorney Mitchell Bierman explained covenant that the shed is not being used for improper use, adding plumbing and power to a shed could make it habitable, and someone would have to covenant that they would not inhabit it.

Vice Mayor Loyzelle proposed an amendment that the font size for assisted living facilities required signage follow Americans with Disabilities Act (ADA) standards. A motion was made by Council Member Mixon, seconded by Council Member Coriat, to accept the amendment.

Mayor Bell amended the proposed Resolution to direct the Town Manager to explore the feasibility of converting Lincoln City Park into a dog park.

There was discussion on the parks master plan, and the possibility of the land being pine rockland.

Mayor Bell opened Public Comments. Marty Bell spoke in favor of the Resolution.

There being no one else wishing to speak, Mayor Bell closed Public Comments.

There was discussion on the cost of a feasibility study and time, the possibility to look at the current site and other parks in Town for a dog park, and the possibility of extending the feasibility study to all parks, resident concerns on maintaining the park as a rockland hammock and the size of the park, the possibility of making it a passive park, and discussion in the Parks and Recreation Advisory Committee on the need for a dog park but not at this location.

A motion was made by Mayor Bell, seconded by Council Member Mixon, to approve the Resolution with the amendment directing the Town Manager to look into the feasibility of Lincoln City Park becoming a future dog park.

After further discussion, Mayor Bell called for the vote and the motion passed 3-2, with Council Member Coriat and Vice Mayor Loyzelle voting in opposition.

## 11. PUBLIC COMMENTS

Mayor Bell opened Public Comments. There being no one wishing to speak, Mayor Bell closed Public Comments.

Council Member Mixon spoke on an email she received regarding traffic on Caribbean Boulevard and Cutler Creek West, and an accident.

There was discussion on speed signs, a traffic study for a traffic light, the amount of accidents in the last five years in the area, and discussions with the Home Owners Association.
