1. CALL TO ORDER, ROLL CALL, PLEDGE OF ALLEGIANCE, & MOMENT OF SILENCE

The meeting was called to order by Mayor Tim Meerbott at 7 p.m. Town Clerk Debra Eastman called the roll. Vice Mayor Sue Loyzelle asked for a moment of privilege and presented boutonnieres to all of the Council Members. Mayor Meerbott thanked the Vice Mayor and expressed excitement for his new position.

3. PUBLIC COMMENTS

Mayor Tim Meerbott opened public comments and there were none.

4. REPORTS

A. TOWN MANAGER'S REPORT

- 2018 Local Mitigation Strategy Annual Report

- 2018 Flood Mitigation Project Annual Report

Director of Public Works Alfredo Quintero provided the flood mitigation report and reported on the flood insurance discount provided to residents as a result of the project and effort of staff. Vice Mayor Loyzelle asked that a page be added to the end of the report showing the public information on the grants received saving taxpayer dollars and the members of the Town Council concurred. Mr. Quintero will add the page and post the information on the Town's website. Council Member Michael Callahan asked that there be a banner on the website or some other way of showing the community the positive impact of savings from this project.

- Update - Franjo Park Restorations/Upgrades

Town Manager Rafael Casals explained that he has now compiled a FEMA compliant bid document for lighting for Franjo Park which will be advertised on December 12, 2018. He expects that the granting of the bid will be before the Town Council in February, 2019.

- Update - Lakes by the Bay Canoe Kayak Project

Town Manager Rafael Casals explained that the plans for this project are completed and that he is waiting for a Class 1 permit from DERM.

- Update - Town Hall Property Exchange Letter of Intent (Reso 18-83)

Town Manager Rafael Casals explained that the Letter of Intent has been executed, monetary deposits have been exchanged and they are in the phase of selecting appropriate appraisers.

C. TOWN CLERK'S REPORT

Town Clerk Debra Eastman reminded the Town Council of the January 9, 2019 Town Council Workshop, January 16, 2019 Regular Town Council Meeting and January 17, 2019 Zoning Workshop.

5. CONSENT AGENDA

Vice Mayor Loyzelle requested to pull item 5B from the consent agenda. A motion was made by Council Member Coriat and a second was received from Council Member Callahan to approve the Consent Agenda. Mayor Meerbott called the roll and the motion was adopted 5-0.

- A. A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, RESCINDING RESOLUTION NO. 17-82 AUTHORIZING THE TOWN

MANAGER TO ISSUE A PURCHASE ORDER TO KIMLEY-HORN AND ASSOCIATES, INC. FOR THE FINAL TOWN CENTER PLAZA CONSTRUCTION PLANS AND DESIGN SERVICES; AND PROVIDING FOR AN EFFECTIVE DATE.

This Resolution was adopted on Consent.

- B.** A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, APPROVING A JOINT USE AGREEMENT WITH MATER ACADEMY FOUNDATION, INC. FOR THE USE OF MATER ACADEMY CUTLER BAY LOCATED AT 22025 SW 87 AVENUE; PROVIDING FOR AUTHORIZATION; AND PROVIDING FOR AN EFFECTIVE DATE.

Town Clerk Debra Eastman read the title of the resolution. Vice Mayor Loyzelle questioned item 6.1 on page 3 of the agreement and asked for language to further clarify the definition of an event and adding the following language to item 6.1. "The Town may elect to conduct less than eight events per year. A program conducted over a multi-day period shall constitute one event for purposes of the minimum event requirements of this Section." Town Attorney Mitch Biermann was in agreement with the additional language. A motion was made by Vice Mayor Loyzelle, seconded by Council Member Duncan, that this Resolution be adopted as amended. The motion carried by an unanimous vote. (5-0)

Town Clerk Debra Eastman read the title of the ordinance. Alex David of Calvin Giordano and Associates provided a report. Vice Mayor Sue Loyzelle offered the following changes to the report:

- 1) Page 8. Delete "and dog park at Saga Lake Park" and add the following sentence. "The Town is exploring the feasibility of a dog park at Lincoln City Park".
- 2) Pages 8/9. Under Town Park Facilities each park will have its park category listed.
- 3) Page 10. COAST will be spelled out – Cutler Bay Ocean Academy of Science and Technology.
- 4) Page 11. Correct error to read 2018.
- 5) Page 12. Current and Future LOS is determined by Miami-Dade County and FDOT. LOS on roadway segments may change over time based on capacity

improvements, transportation improvements and population and employment changes.

6) Page 14. SW 184th will be changed to SW 186th.

7) Page 19. SW 184th will be changed to SW 186th.

A motion was made by Council Member Coriat, seconded by Council Member Duncan, that this Ordinance be approved on first reading. The motion carried by the following vote:

Vice Mayor Sue Loyzelle spoke about concerns voiced by Whispering Pines HOA that a vacant parcel is being considered by the Town for a park. Other Council Members expressed that they too have been approached by residents in that area and have expressed that there are no plans for purchase and development of that vacant parcel. It was made clear by the Town Manager and members of the Town Council that the parcel was only identified as vacant and never under consideration for development. The vacant parcel is not for sale.

Mayor Meerbott requested that the members of the Town Council bring their hopes and dreams to the table for the Jan. 9, 2019 Workshop for discussion. Council Member Robert Duncan expressed his gratitude and excitement to serve on the Town Council.
