## US1/SR5 at SW 186 St./SR994 Pedestrian Safety Improvement

### Project Abstract:

The Florida Department of Transportation is developing the design for roadway improvements along SR994/SW 186 Street from east of SR821/Florida's Turnpike to SR5/US 1 in Miami-Dade County (See *Attached Public Hearing Notification*). **The Town requests that FDOT extend the project boundaries** to include upgrading pedestrian crossing signs and signals, allowing pedestrians to safely cross SR5/US 1 at SR994/SW 186 Street and access the busway. The estimated cost for this project is **\$391,902** based on a similar project that FDOT completed on US 1/SR5 at SW 200<sup>th</sup> Street (Project #437873-1-52-01).

The Town requests that FDOT designs and constructs the pedestrian safety enhancements that may include;

- Providing high emphasis crosswalks at the intersection
- Adding median with landscape and steel loop fence
- Removing existing 4-foot wide traffic separator and reduce lane widths to provide wider median
- Installing pedestrian signage
- Repaving and restriping the roadway
- Adding lighting to the northwest and southwest corner of the intersection

The Florida Department of Transportation (FDOT) is developing the design for two roadway improvement projects along SR 994/Quail Roost Drive/SW 186 Street from east of SR 821/Florida's Turnpike to SR 5/US 1/South Dixie Highway, in Miami-Dade County.

### PROJECT DETAILS

- Installing plastic poles in the median along SR 994/Quail Roost Drive/SW 186 Street between SR 5/US 1 and the busway
- Updating the existing traffic light at the southbound approach at Homestead Avenue
- Repaving and restriping the roadway
- Upgrading pedestrian crossing signs and installing new signals
- Reconstructing damaged driveways and sidewalks
- Improving drainage
- Upgrading traffic signs

### ESTIMATED PROJECT COST

\$2.1 million

### PROJECT DATES

Work is expected to begin in June 2021 and last about eight months. Please note that the construction duration is subject to change.

### MUNICIPALITIES IN PROJECT AREA

Unincorporated Miami-Dade  
Town of Cutler Bay

### POSSIBLE EFFECTS DURING CONSTRUCTION

Work will be done in phases to reduce the effects of construction on the community.

### MAINTENANCE OF TRAFFIC

Temporary lane closures will be during non-peak hours and will have minimum impacts on traffic. Access to all businesses will be maintained during construction. Pedestrian traffic will be temporarily impacted.
