A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA APPROVING AN ASSIGNMENT AND ASSUMPTION OF THE CONTINUING PROFESSIONAL SERVICES AGREEMENT WITH KEITH AND SCHNARS, P.A. TO KCI TECHNOLOGIES, INC.; PROVIDING FOR AUTHORIZATION; AND PROVIDING FOR AN EFFECTIVE DATE.

Section 3. Authorization. The Town Manager is authorized to execute the Assignment, attached hereto as Exhibit "A", and any required documents necessary to transfer the Agreement to the Assignee, subject to approval of the Town Attorney as to form, content, and legal sufficiency.
