RESOLUTION 19-

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, ACCEPTING AN URBAN AND COMMUNITY FORESTRY MATCHING GRANT IN THE AMOUNT OF \$10,000; APPROVING A FEDERAL FINANCIAL ASSISTANCE SUBRECIPIENT AGREEMENT WITH THE FLORIDA DEPARTMENT OF AGRICULTURE AND CONSUMER SERVICES; PROVIDING FOR AUTHORIZATION; AND PROVIDING FOR AN EFFECTIVE DATE.

- WHEREAS, pursuant to the Town of Cutler Bay (the "Town") Resolution No.18-80, the Town applied for an Urban and Community Forestry Grant ("Grant"), which would provide monies to help fund the "Cutler Bay Reforestation Project" ("Project"); and
- **WHEREAS**, the purpose of the Grant program is to cooperate with local governments to promote the planting and protection of trees to improve the livability of urban environments within the State of Florida; and
- **WHEREAS**, the Florida Department of Agriculture and Consumer Services ("FDACS") has notified the Town that it has been awarded the Grant; and
- **WHEREAS,** the Town will receive funding in the amount of \$10,000 for the Project and provide matching funds of \$10,000; and
- **WHEREAS**, the Town Council desires to accept the 2018-19 Grant from the Florida Forest Service, a division of FDACS, and authorize the Town Manager to execute the FDACS Federal Financial Assistance Subrecipient Agreement attached hereto as Exhibit "A" ("Agreement"); and
- WHEREAS, the Town finds that adoption of this resolution is in the best interest and welfare of the residents of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

- Section 1. Recitals. That each of the above stated recitals is hereby adopted and confirmed.
- **Section 2. Grant Accepted.** The Town Council hereby accepts the Grant of \$10,000.00 from FDACS for the Project.
- **Section 3. Approval.** The Town Council hereby approves the Agreement in substantially the form attached hereto as Exhibit "A."
