### MEMORANDUM

Re: Recommendation pursuant to RFQ #19-02, Financial Advisory Services

The Town Council on January 16, 2019 via Resolution # 19-03 authorized staff to issue an Request for Qualifications (RFQ) # 19-02: Financial Advisory Services. The RFQ had a due date and time of March 14, 2019 at 3:00 p.m. The Town received five (5) sealed bid packages from potential firms which were publicly opened at Town Hall. The bid opening summary is provided as Attachment "I".

An Evaluation Selection Committee was created by the Town Manager to evaluate the proposals and consisted of the following Town staff:

- Robert Daddario, Finance Director (Committee Chair),
- Alfredo Quintero, Public Works Director, and
- Lakeesha Morris, Grants Coordinator.

The Selection Committee met on March 20, 2019 at 3 p.m. at Town Hall to evaluate the written proposals submitted. Five responses were evaluated, four of which received average scores in excess of 93 (the average score of the fifth response was below 88). Each committee member's evaluation form is attached (Attachment "II"). The written proposal, pursuant to the RFQ, was weighted as 75% of a respondent's total score.

The top 4 ranked respondents were invited to make oral presentations pursuant to the RFQ. Oral presentations were made on March 27, 2019, commencing at 9 a.m. at Town Hall. The oral presentation, pursuant to the RFQ, was weighted as 25% of a respondent's total score. Each committee member's evaluation form is attached (Attachment "III").



After tabulating the Selection Committee's evaluation forms for both the written RFQ response and the oral presentation, and weighting as outlined in the RFQ, the respondents were ranked as follows:

- 1. Estrada Hinojosa & Co., Inc. (95.67 points)
- 2. Public Resources Advisory Group (95.00 points)
- 3. (tied) Hilltop Securities and Masterson Advisors (93.67 points each)

In addition to including each committee member's evaluation form mentioned above, attached please find a summary tabulation sheet calculating each respondent's total score based on the weighting of the written response score and the oral presentation score (Attachment "IV").

Although all four respondents are qualified firms for the scope of work outlined in RFQ#19-02, the Selection Committee recommends that the top ranked respondent, Estrada Hinojosa & Co., Inc., be selected as the "Financial Advisor" (consultant) to provide financial advisory services to the Town.
