RESOLUTION NO. 19-

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, APPROVING AN AMENDMENT TO THE TOWN'S PLANNING AND ZONING FEE SCHEDULE; AND PROVIDING FOR AN EFFECTIVE DATE.

- **WHEREAS**, on February 17, 2016, the Town of Cutler Bay (the "Town") Town Council adopted Ordinance No. 16-01, amending Article III, Section 3-30 "General Requirements for Applications" and created a Cost Recovery Fee Process; and
- **WHEREAS**, Ordinance No. 16-01 establishes a process for individuals filing a land development application to prepay the Town an Initial Preliminary Deposit at the time of submittal; and
- **WHEREAS**, the Initial Preliminary Deposit provides the Town funds to initiate a review of the submitted land development application package; and
- **WHEREAS**, the Town Council, adopted Resolution No. 16-15 amending the Town's Planning and Zoning Fee Schedule to include Initial Preliminary Deposit fees; and
- **WHEREAS**, Resolution No. 16-15 did not provide an Initial Preliminary Deposit for the Town to conduct the required traffic study on behalf of the applicant; and
- WHEREAS, the Town Council finds that it is necessary to revise the Planning and Zoning Department Fee Schedule in order to include a traffic study Initial Preliminary Deposit authorizing the Town's Planning and Zoning Department to assign this task to a professional consultant selected by the Town through a competitive bidding process; and
- **WHEREAS**, the traffic study Initial Preliminary Deposit Fee ensures a fair and efficient process that will be managed by Town staff and consultants; and
- **WHEREAS**, the Town finds that this Resolution will promote the health, safety and welfare of the Town.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, THAT:
