## **RESOLUTION NO. 19-**

## A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AUTHORIZING THE ISSUANCE OF A REQUEST FOR PROPOSALS (RFP) FOR EMERGENCY DEBRIS ROAD CLEARING SERVICES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in the past, the Town of Cutler Bay (the "Town") has experienced threats to residents' health, safety, welfare and property, as a result of natural disasters such as hurricanes, floods, tornadoes and other severe weather events; and

WHEREAS, the Town seeks to provide emergency assistance and debris road clearing services to its residents in the event of a natural or national disaster, terrorism or any other emergency event affecting the health, safety, welfare and property of the Town, its residents and businesses; and

WHEREAS, pursuant to Section 12-21 of the Town's Code, the Town Manager shall perform the function of Director of Emergency Management; shall implement, manage and report on all actions authorized and taken; and shall plan for the coordination of those actions necessary for the creation and maintenance of an effective emergency response capability to prepare for and manage emergency conditions; and

WHEREAS, during a declared State of Emergency, the Town Manager may deem it necessary to authorize emergency debris road clearing services; and

WHEREAS, Town staff has prepared a FEMA compliant Request for Proposal (the "RFP") No. 19-09 for Emergency Debris Road Clearing Services for roads located within the Town limits, attached hereto as Exhibit "A"; and

WHEREAS, Section 24-45 of the Town's Code requires the Town Manager to obtain authorization from the Town Council to advertise solicitations for bids and proposals prior to advertising the solicitation; and

WHEREAS, the Town Council has reviewed the RFP and desires to authorize its advertisement; and

WHEREAS, the Town Council finds that this Resolution is in the best interest of the health, safety and welfare of the residents of the Town.

## NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, THAT:

Section 1. <u>Recitals.</u> The above recitals are true and correct and are incorporated herein by this reference.

Section 2. <u>Authorization</u>. The Town Manager is hereby authorized to advertise and issue RFP No. 19-09 for Emergency Debris Road Clearing Services for the Town, in substantially the form attached hereto as Exhibit "A."

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.
