

RESOLUTION NO. 18-52

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL
OF THE TOWN OF CUTLER BAY, FLORIDA,
SUPPORTING THE CITY OF SOUTH MIAMI'S
RESOLUTION ENCOURAGING THE MIAMI-DADE
COUNTY BOARD OF COUNTY COMMISSIONERS TO BAN
PLASTIC STRAWS OR RESTRICT THEIR USE;
PROVIDING FOR TRANSMITTAL; AND PROVIDING FOR
AN EFFECTIVE DATE.**

WHEREAS, the Town of Cutler Bay (the "Town") declares that plastic straws pose an unnecessary environmental hazard to the health, safety, and welfare of the residents of Cutler Bay as well as negatively impacting the Town's water quality and surrounding marine life; and

WHEREAS, plastic straws are non-biodegradable and can take several decades to deteriorate in the environment or landfill as most are not recycled; and

WHEREAS, on June 19, 2018, the City of South Miami adopted Resolution No. 117-18-15150, attached hereto as Exhibit "A," (the "South Miami Resolution") urging the Miami-Dade County Board of County Commissioners to ban plastic straws or restrict their use; and

WHEREAS, according to the Florida Department of Environmental Protection, plastic straws are a common pollutant that photo grade or break down into more harmful, smaller pieces that last hundreds of years and are ingested by marine life and other wildlife, thus harming and killing them; and

WHEREAS, *National Geographic* estimates that plastic straws have killed an estimated one million sea birds and one hundred thousand marine mammals; and

WHEREAS, *The Guardian* estimates that by 2050, there will be more plastic straws than fish in the ocean; and

WHEREAS, the Town Council finds that the adoption of this Resolution is in the best interest and welfare of the residents of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:


Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Supporting South Miami Resolution. The Town Council supports the South Miami Resolution, which urges and recommends that the Miami-Dade County Board of County Commissioners ban plastic straws or restrict their use.

Section 3. Transmittal. The Town Clerk is hereby directed to transmit a copy of this Resolution to the Miami-Dade County Board of County Commissioners.

Section 4. Effective Date. This Resolution shall be effective immediately upon adoption.

RESOLUTION NO. 117-18-15150

A Resolution of the Mayor and City Commission for the City of South Miami encouraging Miami-Dade County Board of County Commissioners to ban plastic straws or restrict their use.

WHEREAS, the straw in the average glass of water served in a restaurant will be used for just a few minutes, but in the environment, it can last more than several lifetimes; and

WHEREAS, wax paper straws wrapped in plastic were successfully used for many decades before the invention of single use plastic straws; and

WHEREAS, plastic straws, though small, cause serious harm to our environment for a number of reasons: it easily finds its way into our waterways due to its lightweight nature, it doesn't biodegrade, but instead it fragments into smaller pieces which are frequently mistaken for food by marine animals, and it can't be recycled; and

WHEREAS, the harmful effects of the unmitigated use of plastic straws and other plastic products are currently being seen in our environment and, once in the environment, plastic enters our food chain where, increasingly, microplastic particles are turning up in our stomachs, blood and lungs – the effects of which are only beginning to be studied; and

WHEREAS, a recent article in *National Geographic* stated that: "One million seabirds and 100,000 marine mammals are killed annually by plastic in our oceans. Forty-four percent of all seabird species, 22 percent of whales and dolphins, all sea turtle species, and a growing list of fish species have been documented with plastic in or around their bodies."¹; and

WHEREAS, British Prime Minister, Theresa May, was quoted in a *BBC* article on April 19, 2018, saying that plastic waste was "one of the greatest environmental challenges facing the world"²; and

WHEREAS, the United Kingdom is part of the growing list of countries that have banned or will be banning single-use plastics such as plastic straws; and

WHEREAS, according to a June 5, 2018 article in *The Guardian*, current projections show that global plastic production will skyrocket in the next 10-15 years. This year alone, manufacturers will produce an estimated 360m tonnes. With a booming population driving demand, production is expected to reach 500m by 2025 and a staggering 619m tonnes by 2030³; and

WHEREAS, we are so dependent on plastic in our everyday lives and it will take a movement, a shift in mindset to tackle this problem; and

WHEREAS, we each have a part to play in curbing our plastic consumption: individually, we can act as responsible and informed consumers, the private sector can adopt business practices that reflect environmental responsibility, and governments can enact policies that mandate the responsible production and use of plastics; and

WHEREAS, it is time for Miami-Dade County to take a first-step towards action and ban plastic straws.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF SOUTH MIAMI, FLORIDA THAT:

Section 1. The Mayor and City Commission for the City of South Miami encourage the Miami-Dade County Board of County Commissioners to ban the use of plastic straws or require restaurants to discourage the use of plastic straws and only provide plastic straws upon request.

Section 2. The City Clerk shall send a copy of this resolution to each member of the County Commission, the League of Cities, and each municipality in Miami-Dade County.

Section 3. Severability. If any section clause, sentence, or phrase of this resolution is for any reason held invalid or unconstitutional by a court of competent jurisdiction, the holding shall not affect the validity of the remaining portions of this resolution.


Section 4. Effective Date. This resolution shall become effective immediately upon adoption by vote of the City Commission.


