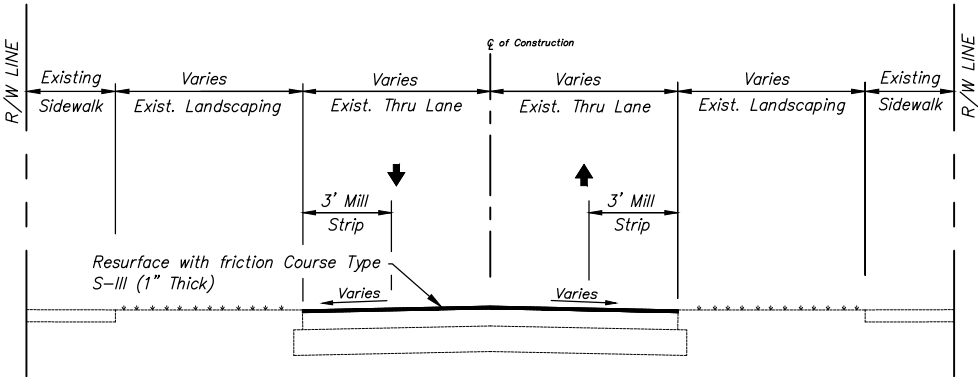

NOTES:

1. AT MATCH POINTS TO EXISTING ASPHALT TO REMAIN, CONTRACTOR SHALL MILL A MINIMUM 5' WIDE STRIP TO MATCH NEW PAVEMENT ELEVATION WITH EXISTING ELEVATION.
2. CONTRACTOR SHALL PLACE TEMPORARY STRIPING THE SAME DAY PAVING IS COMPLETED. THE THERMO PLASTIC PAVEMENT MARKINGS SHALL BE PLACED NO EARLIER THAN 30 DAYS AFTER ASPHALT OVERLAY COMPLETION.
3. ALL VALVES AND MANHOLES WITHIN PROJECT LIMITS SHALL BE ADJUSTED BY CONTRACTOR.
4. CONTRACTOR SHALL MILL A CONTINUOUS 3' STRIP AT BOTH EDGES OF PAVEMENT TO MATCH FLUSH WITH ALL DRIVEWAYS.
5. CONTRACTOR SHALL MILL & PROVIDE ASPHALT LEVELING COURSE AT LOCATIONS AS DIRECTED BY TOWN AND/OR ENGINEER.
6. ALL BARRICADES AND EQUIPMENT SHALL BE MAINTAINED FREE OF GRAFFITI AT ALL TIMES.
7. CONTRACTOR SHALL TAKE ALL APPROPRIATE MEASURES TO PROTECT ALL EXISTING PAVERS & CONCRETE WITHIN AND ADJACENT TO PROJECT LIMITS. ANY DAMAGE OR TRACKING OF ASPHALT AND TACK IS CONTRACTOR'S RESPONSIBILITY TO REMOVE OR REPLACE TO THE SATISFACTION OF ENGINEER AND TOWN.
8. CONTRACTOR SHALL TAKE ALL APPROPRIATE MEASURE TO PROTECT ALL EXISTING DRIVEWAYS, MAILBOXES, LANDSCAPING, ETC. WITHIN AND ADJACENT TO PROJECT LIMITS. ANY DAMAGE OR TRACKING OF ASPHALT AND TACK IS CONTRACTOR'S RESPONSIBILITY TO REMOVE OR REPLACE TO THE SATISFACTION OF ENGINEER AND TOWN.
9. CONTRACTOR SHALL REMOVE ALL MILLING AND ASPHALT DEBRIS THE SAME DAY THE DEBRIS IS CREATED. ANY DEBRIS LEFT OVERNIGHT MAY BE REMOVED BY THE TOWN AT CONTRACTOR'S EXPENSE.
10. CONTRACTOR SHALL ACHIEVE A STRAIGHT EDGE OF PAVEMENT AT ALL PROPERTIES.
11. STAGING AREA WILL BE IDENTIFIED BY TOWN AND/OR ENGINEER.

CONTRACTOR SHALL VERIFY ALL QUANTITIES TO ENSURE TOTAL CONTRACT AMOUNT FOR THE VARIOUS WORK ITEMS ESTABLISH A TOTAL PRICE FOR COMPLETING THE JOB IN IT'S ENTIRETY.

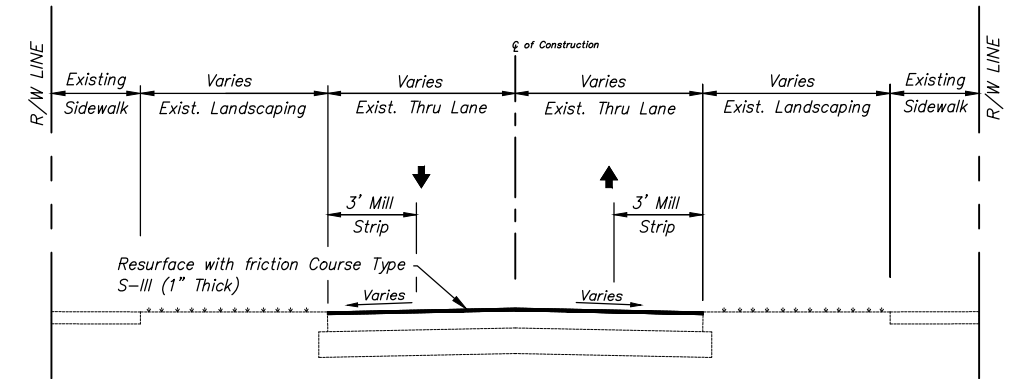

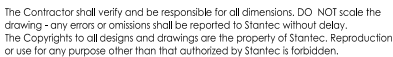
