

**RESOLUTION NO. 19-\_\_**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, ADOPTING THE PROPOSED MILLAGE RATE OF THE TOWN OF CUTLER BAY FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2019 THROUGH SEPTEMBER 30, 2020 PURSUANT TO FLORIDA STATUTES SECTION 200.065; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, on July 17, 2019 the Town Council of the Town of Cutler Bay (the “Town”) adopted Resolution No. 19-53 determining the proposed millage rate for the fiscal year commencing October 1, 2019 and further scheduled the first public hearing required by Section 200.065 of the Florida Statutes to be held on September 10, 2019 at 7:00 p.m.; and

**WHEREAS**, the Property Appraiser properly noticed the first public hearing scheduled for September 10, 2019, 7:00 p.m., at the Cutler Bay Town Hall, 10720 Caribbean Blvd., Cutler Bay, Florida, as required by Chapter 200 of the Florida Statutes; and

**WHEREAS**, the first public hearing, as required by Section 200.065(2)(c), was held by the Town Council on September 10, 2019 as previously noticed and the public and all interested parties had the opportunity to address their comments to the Town Council and the Town Council has considered the comments of the public regarding the proposed millage rate and has complied with the notice requirements of Florida Statutes.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF CUTLER BAY, FLORIDA AS FOLLOWS:**

**Section 1. Recitals Adopted.** That the above-stated recitals are hereby adopted and confirmed.

**Section 2. Adoption of Proposed Millage Rate.** That the proposed millage rate for the Town of Cutler Bay for the fiscal year commencing October 1, 2019 through September 30, 2020 be and is hereby fixed at the rate of \_\_\_\_\_ mills per \$1,000.00 of assessed property value within the Town of Cutler Bay which is \_\_\_\_\_ percent greater than the roll-back rate of \$2.2903 mills per \$1,000.00 of assessed property value.

**Section 3. Effective Date.** This resolution shall be effective immediately upon its adoption.
