RESOLUTION NO. 19-

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, SUPPORTING THE MIAMI-DADE COUNTY PUBLIC SCHOOLS BOARD'S 2020 STATE LEGISLATIVE PROGRAM; PROVIDING FOR TRANSMITTAL; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in April 2012, the Town of Cutler Bay (the "Town") Town Council adopted Resolution No. 12-21 approving an Interlocal Agreement with the Miami-Dade County Public School ("MDCPS") Board for the purpose of establishing additional education choices within the Town; and

WHEREAS, the Town desires to express its support of MDCPS Board's 2020 State of Florida Legislative Program; and

WHEREAS, the MDCPS Board has approved a state legislative program, encouraging the Florida legislature to fund several key measures related to public schools in the district; and

WHEREAS, the state legislative program addresses key measures such as increasing the Base Student Allocation (BSA); implementing a revised District Cost Differential (DCD) ensuring that the DCD takes into account cost differences integral to educational institutions' operations; extending the authorization of the locally-voted levy for operating purposes; funding select student programs beyond the 1.0 Full- Time Equivalent (FTE) cap or 25 hours a week, and amending the Marjory Stoneman Douglas Safety Act and others as described in Exhibit "A"; and

WHEREAS, the Town Council deems it to be in the best interest and welfare of the residents of the Town to support the MDCPS Board 2020 State of Florida Legislative Program.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:
