

RESOLUTION NO. 20-__

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, ADOPTING THE TOWN OF CUTLER BAY MOBILITY HUBS PLAN; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Cutler Bay (the “Town”) adopted Resolution No. 18-62 accepting a grant from the Miami-Dade Transportation Planning Organization (the “TPO”) in the amount of \$50,000.00 to develop a Mobility Hubs Plan (the “Plan”); and

WHEREAS, the Town Council subsequently adopted Resolution No. 18-63 authorizing Marlin Engineering, Inc. (the “Consultant”) to develop the Town’s Plan; and

WHEREAS, the Consultant held several public meetings with Town staff and a series of public involvement meetings/workshops from April 2019 through September 2019; and

WHEREAS, the Consultant incorporated the feedback from Town staff and resident’s comments in the Plan, and subsequently presented the final draft of the Plan, which is attached hereto as Exhibit “A”; and

WHEREAS, the Town recognizes its growing population will require the efficient use of mobility hubs to improve transit performance, connectivity and safety for pedestrian, bicyclists and transit users of all ages and all abilities; and

WHEREAS, the Town recognizes the importance of being proactive in developing a greener, healthier, aesthetically pleasing, dynamic, vibrant, and cosmopolitan community; and

WHEREAS, the Town desires to create an efficient multimodal transportation network that promotes the health and mobility of all citizens and visitors of all ages and abilities while reducing the negative impacts on the environment; and

WHEREAS, the Plan aligns with the Town’s adopted 2014-19 Strategic Master Plan’s Goal No. 3.1 to provide the infrastructure needed to meet current and emerging needs of the community and Goal No. 6.2 to optimize the smooth flow of traffic through the Town by minimizing traffic congestion and maximizing the capacity of our local roadways; and

WHEREAS, the Town Council finds that the adoption of this Resolution is in the best interest of the health, safety and welfare of the residents of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Adoption and Implementation of Mobility Hubs Plan. That the Town Council hereby adopts the Town of Cutler Bay Mobility Hubs Plan, in substantially the form attached hereto as Exhibit "A."

Section 3. Implementation. The Town Manager is authorized to take all actions necessary to implement the projects identified in the Mobility Hubs Plan.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
