### FLOODPLAIN MITIGATION PLAN NOTICE OF PUBLIC MEETING

The Town of Cutler Bay will hold a public meeting of the Floodplain Mitigation Advisory Committee on **Tuesday, February 25, 2020 at 5:30 PM** in the Cutler Bay Town Center Community Room, 10720 Caribbean Blvd, Suite 220, Cutler Bay, FL 33189.

The Committee meeting will be followed at 7:00 PM by a Community Meeting to discuss updates to the Town's adopted 2015 Floodplain Mitigation Plan and to inform property owners how to save on your flood insurance policies. The Town has achieved a Community Rating System Class 4 Rating. This program rewards communities with flood insurance premium discounts for going above and beyond the minimum requirements of the National Flood Insurance Program.

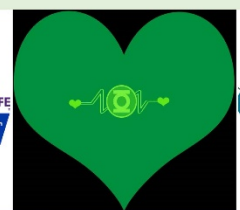
Effective October 1, 2019, all flood insurance policy holders within the Town of Cutler Bay are eligible to receive a thirty percent (30%) discount each year on the cost of flood insurance.
