A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, GRANTING FINAL PLAT APPROVAL FOR MARLIN ESTATES FOR PROPERTY GENERALLY LOCATED WEST OF BELVIEW DRIVE AND SOUTHWEST OF S.W. 191 STREET, AS LEGALLY DESCRIBED IN EXHIBIT "A" ON APPROXIMATELY 1.25 ACRES; AND PROVIDING FOR AN EFFECTIVE DATE.

- WHEREAS, Rafael and Mirta Puig (Puig Family Trust) (the "Applicant") has submitted an application to the Town of Cutler Bay (the "Town") to approve the final plat for Marlin Estates for property legally described in Exhibit "A" (the "Final Plat"); and

- **Section 2. Approval**. The Town Council hereby approves the Final Plat attached hereto as Exhibit "B."
- **Section 3. Conditions.** The approval granted by this Resolution is subject to compliance with the following conditions:
 - 1. The execution of a Declaration of Protective Covenants, if required, as provided by Section 3-197 of the Town Code prior to the issuance of the first building permit.
- <u>Section 4.</u> <u>Recording.</u> The Town, or the Applicant if so requested by the Town Clerk, shall record this Resolution at the Applicant's sole expense in the Public Records of Miami-Dade County, Florida.
