The Oral presentations were scheduled on January 13, 2020, in Town Hall's Community Room. Each Selection Committee Member individually awarded points to the top ranked firms, after the scheduled Oral Presentations. As per RFQ No. 19-10, the Oral Presentation is worth twenty-five percent (25%) of the average score in the final scoring and the original response evaluation criteria is worth seventy-five percent (75%) of the average score in the final combined scoring. After tabulating the Selection Committee's results (Attachment "II"), the top five (5) firms re-ranked as follows:
