There was discussion on a Letter of Intent for the possible acquisition of property located at SW 184 ST and Old Cutler Road. A motion was made by Council Member Coriat, seconded by Vice Mayor Loyzelle, that this Resolution be adopted. Mayor Meerbott called for the vote, and the motion carried by an unanimous vote (4-0).
