

## Spooked horse rescued after being trapped on bridge

A runaway horse named Vertigo was rescued late Wednesday after partially falling through a wooden pedestrian bridge at a park in Plantation.

Vertigo was being ridden by his owner along Northwest 118 Avenue, near Volunteer Park, when a passing car spooked him, said Aston Bright, spokesman for Plantation Fire Rescue.

He “reared up and freaked out,” Bright said.

When the owner got off to calm him down, Vertigo took off running into the park, at 12050 W. Sunrise

Blvd. The 1,100-pound horse eventually made his way onto the park’s pedestrian bridge. That’s when several boards gave way and he fell.

He couldn’t get up. His right hind leg was trapped in the hole.

When Plantation Fire Rescue and Davie Fire Rescue’s specialized animal rescue unit for large animals (such as horses) arrived, Vertigo was flailing about and trying to escape. The situation looked bad, Bright said.

A 50-ton tow truck with a boom was called in to help hoist the horse out of the hole. The rescue went smoothly, except for one

moment, when Vertigo is seen nearly kicking one of his rescuers while being lifted out of the hole.

Vertigo was eventually sedated and dragged off the bridge for a checkup with Dr.

Tiffany Trotter, an equine veterinarian. He had lacerations on his leg but it didn’t appear to be fractured.

About an hour after the rescue, Vertigo then got up by himself.

### TOWN OF CUTLER BAY NOTICE OF PUBLIC HEARING

**NOTICE IS HEREBY GIVEN** that the Town Council of the Town of Cutler Bay, Florida, will hold a public hearing on **Wednesday, June 17, 2020 at 7:00 p.m.**, or as soon thereafter as possible. Pursuant to Governor DeSantis’ Executive Orders 20-51 and 20-52, in which the Governor declared a public health emergency and a state of emergency, there is a recommendation to limit public gatherings. On March 20, 2020, Governor DeSantis issued Executive Order 20-69, “Emergency Management - COVID-19 Local Government Public Meetings.” Pursuant to Executive Order 20-69, “any Florida Statute that requires a quorum to be present in person or requires a local government body to meet at a specific public place” is suspended, and the Town is authorized to hold public meetings through the use of communications media technology, subject to the adoption of rules pursuant to Section 120.54(5)(b)2, Florida Statutes. On April 14, 2020, Town Manager Casals issued Emergency Order No. 20-03, providing rules of procedure for Public Meetings utilizing communications media technology, including instructions on how to access the public meeting either via telephone, video conference, or other communications media technology utilized by the Town.
