

RESOLUTION 20-__

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, APPROVING AN AWARD OF \$7,500.00 IN GRANT FUNDING FROM THE CUTLER BAY COMMUNITY FUND TO SUPPORT LOCAL NOT-FOR-PROFIT ORGANIZATIONS PROVIDING EDUCATIONAL DEVELOPMENT AND SOCIAL SERVICE PROGRAMS FOR THE TOWN'S YOUTH; PROVIDING FOR AUTHORIZATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on July 17, 2013, the Town of Cutler Bay ("Town") approved Resolution No. 13-57 establishing the Cutler Bay Community Fund ("Fund") as a donor advised fund between the Town and the Miami Foundation; and

WHEREAS, the Fund was created to support nonprofit organizations that endeavor to improve the life of residents in the Town through educational, aesthetic (community beautification), environmental, cultural, social services, and other philanthropic programs and services; and

WHEREAS, COAST Academy Parent Association, Inc. ("CAPA"), DEEP Foundation, Inc. ("DEEP"), and Season's Hospice Foundation submitted requests for funding that are in accordance with the Fund's mission; and

WHEREAS, the Town Council wishes to authorize the Town Manager to award grant dollars in the amount of \$2,500.00 to CAPA for the Deering Estate Nurturing Environmental Stewards of Today and Tomorrow ("NESTT") Program Field Trips; and

WHEREAS, the Town Council wishes to authorize the Town Manager to award grant dollars in the amount of \$2,500.00 to DEEP for the Cutler Bay Scuba Program; and

WHEREAS, the Town Council wishes to authorize the Town Manager to award grant dollars in the amount of \$2,500.00 to Season's Hospice Foundation for the Camp Kangaroo Miami Program; and

WHEREAS, the Town finds that this resolution will promote the health, safety, and welfare of the Town.

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That each of the above stated recitals is hereby adopted and confirmed.

Section 2. **Approval.** The Town Council hereby approves the award of grant dollars from the Fund in the amount of \$2,500.00 to CAPA for the Deering Estate NESTT Program Field Trips; \$2,500.00 to DEEP for the Cutler Bay Scuba Program; and \$2,500.00 to Season's Hospice Foundation for the Camp Kangaroo Program, for a total allocation of \$7,500.00 in grant funds.

Section 3. **Authorization.** The Town Council hereby authorizes the Town Manager to take any and all steps necessary to implement the intent and purpose of this Resolution.

Section 4. **Effective Date.** This Resolution shall become effective immediately upon adoption.
