

# Feature Story: Cutler Bay is adding more trees to our Town!

Neat Street's Miami awarded Street Tree Matching Grant

This year, the Town received a grant from Neat Street to further expand our Tree City goals. Trough the grant, our contractor Visualscapes – Commercial Landscape planted 75 new Florida native trees (Gumbo Limbo and Green Buttonwood Trees) throughout the Town including public swales by residential homes and Cutler Bay Middle School.



These plantings help support Million Trees Miami's initiative to achieve a 30 percent tree canopy cover for Miami-Dade County. The benefits of a substantial tree canopy are priceless; they clean the air, cool the area, help conserve energy, increase property value, and so much more.

### #2020 Census

The results of the #2020Census will inform decisions and proportionately allocate hundreds of billions of dollars in federal funding to communities across the country based on the amount of people that get counted-that includes hospitals, fire departments, school lunch programs, and other critical programs and service. It will also determine how many seats in Congress each state gets. Responding can be done online, by phone, or by mail and should take just a few minutes to do. You should have received your invitation in the mail already with instructions on how to participate. If you have not, the Census will be sending additional mailings soon.
