RESOLUTION 21-

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, DECLARING THE CERTIFYING AND **OFFICIAL RESULTS OF THE TOWN'S NOVEMBER 3, 2020, GENERAL ELECTION AND DECEMBER 1, 2020, RUNOFF** ELECTION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Cutler Bay's ("Town") general election was held on November 3, 2020 (the "General Election"); and

WHEREAS, the Town's registered voters cast votes for the candidates qualified for the Office of the Vice Mayor and Council Member Seat 2 in the General Election; and

WHEREAS, since none of the candidates for Town Council Seat 2 received more than 50% of the vote in the General Election, as required by the Town Charter, the Town's registered voters cast votes for the two candidates who received the most votes for Council Seat 2 on November 3, 2020, in a runoff election held on December 1, 2020 (the "Runoff Election"); and

WHEREAS, the General Election and Runoff Election have been canvassed and the Miami-Dade County Supervisor of Elections has tabulated the ballots of registered voters; and

WHEREAS, the Town Council finds that this Resolution is in the best interest and welfare of the residents of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

Section 1. <u>Recitals.</u> The above recitals are true and correct and are incorporated herein by this reference.

<u>Section 2.</u> <u>Election Results</u>. The Town Council hereby certifies and declares the official results of the General Election held on November 3, 2020, and the Runoff Election held on December 1, 2020, as provided for in Exhibits "A" and "B," respectively, which are attached hereto and incorporated herein.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.
