RESOLUTION NO. 21-

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AUTHORIZING THE TOWN MANAGER TO ISSUE A PURCHASE ORDER TO SRS ENGINEERING, INC. FOR DESIGN SERVICES FOR THE SAGA BAY DRAINAGE SOUTH SUB-BASIN SECTION 1.5 SOUTH WATER QUALITY IMPROVEMENT PROJECT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on August 20, 2008, the Town of Cutler Bay (the "Town) adopted the Stormwater Master Plan via Resolution No. 08-50 for the purpose of identifying opportunities to protect surface water quality and reduce flooding within residential neighborhoods; and

WHEREAS, on August 20, 2014, the Town adopted the 2010 Miami-Dade County Local Mitigation Strategy (the "Local Mitigation Strategy") via Resolution No. 14-55 for the purposes of mitigating potential hazards within the Town; and

WHEREAS, the Saga Bay Drainage Sub-Basin Section 1.5 South was identified as a priority area in both the Stormwater Master Plan and the Local Mitigation Strategy for a water quality improvement project (the "Project"); and

WHEREAS, on April 22, 2020, the Town Council adopted Resolution No. 20-14, authorizing the Town Manager to negotiate and execute a Non-Exclusive Professional Services Agreement (the "Agreement") with SRS Engineering, Inc. (the "Consultant"), among others, to provide various engineering and architectural services for the Town; and

WHEREAS, in accordance with the terms of the Agreement and the provisions set forth in Resolution No. 20-14, the Public Works Department solicited a proposal from the Consultant to provide Design Services (the "Services") for the Project; and

WHEREAS, Town Staff has determined that the Consultant would be the best suited firm to provide the Services for the Project; and

WHEREAS, the Consultant submitted a proposal to the Town with a total fee for the Services for the Project in an amount not to exceed \$79,930.00, which is attached hereto and incorporated herein as Exhibit "A"; and

WHEREAS, the Town has budgeted for the Services for the Project within the 2020-21 Operating Budget and the Project will be funded from the Town's Stormwater Utility Fund; and

WHEREAS, the Town Council finds that this Resolution is in the best interest and welfare of the residents of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, THAT:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Authorization. In accordance with the terms and conditions of Resolution No. 20-14 and the Agreement, the Town Council authorizes the Town Manager to issue a purchase order to Consultant, in an amount not to exceed \$79,930.00, to provide the Services for the Project, as provided in Exhibit "A," attached hereto and incorporated herein

Section 3. Effective Date. This Resolution shall be effective immediately upon adoption.
